RELATING TO THE ENVIRONMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. Chapter 341, Hawaii Revised Statutes, is

7	environmental council, in consultation with the department of

10	establish an interactive, transparent, integrated, and statewide
11	tool for assessing and mapping environmental justice
12	communities, based on the cumulative impacts of all indicators
13	selected by the council to be integrated into the tool.
14	(b) In establishing the tool under subsection (a), the
15	council shall:



8	amended by adding four new definitions to be appropriately

10	"Cumulative impacts" means a measure of how multiple
11	environmental harms, such as exposure to different types of
12	pollution, co-occur and then interact with extant population
13	characteristics, such as health, economic, demographic, and
14	social factors, to produce amplified harm.
15	"Environmental justice" means the fair treatment and
16	meaningful involvement of all people regardless of race, color,
17	culture, national origin, or income, with respect to the
18	development, implementation, and enforcement of environmental
19	laws, regulations, and policies to ensure that each person
20	enjoys:

16	same sum or so much thereof as may be necessary for fiscal year	
17	2022-2023 for the environmental council to develop and maintain	
18	a tool to identify economic justice communities.	
19	The sums appropriated shall be expended by the department	
20	of health	for the purposes of this Act.

3	1 of this Act, the revisor of statutes shall substitute
4	appropriate section numbers for the letters used in designating
5	the new sections in this Act.
6	SECTION 6. New statutory material is underscored.
7	SECTION 7. This Act shall take effect upon its approval;
8	provided that part II shall take effect on July 1, 2021.
