A BILL FOR AN ACT

RELATING TO ACCESS TO LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. The purpose of this Act is to:
2	(1)	Establish the Hawaii early childhood educator stipend
3		program; and
4	(2)	Clarify and make adjustments to Act 46, Session Laws
5		of Hawaii 2020, to reflect the current situation
6		brought upon by the coronavirus 2019 pandemic and
7		improve assessment of the longitudinal education and
8		workforce outcomes of students who were provided with
9		early childhood services.
10	SECT	ION 2. Chapter 302L, Hawaii Revised Statutes, is
11	amended by	y adding a new section to be appropriately designated
12	and to rea	ad as follows:
13	" <u>§30</u> :	2L- Hawaii early childhood educator stipend program.
14	(a) There	e is established the Hawaii early childhood educator
15	stipend p	rogram to be administered by the office to address the
16	shortage (of early childhood educators who have coursework in
17	early chi	ldhood education.

2	considera	tion if the individual:
3	(1)	Is enrolled at a University of Hawaii campus or in a
4		University of Hawaii program and qualifies for Hawaii

7		program in early childhood education, including those

3	(1)	For each year less than the designated number of years
4		that a stipend recipient does not meet the work
5		requirements of subsection (c), the recipient shall
6		repay a proportionate percentage of the total stipend
7		funds received; and
8	(2)	The repayment shall be subject to the terms and
9		conditions set by the office for stipend repayment,
10		including circumstances under which recipients may be
11		eligible for deferment or forgiveness due to hardship
12		or inability to secure employment, as well as
13		potential for fees for the collection of delinquent
14		repayment.
15	Stipend f	unds repaid by a stipend recipient pursuant to this
16	subsectio	n shall be deposited into the early learning special
17	fund esta	blished pursuant to section 302L-5.
18	<u>(e)</u>	In accordance with chapter 103D, the office may enter
19	into writ	ten contracts with collection agencies to collect
20	delinquen	t repayment of stipends owed to the office pursuant to
21	subsectio	n (d). A collection agency that enters into a written

- 8 SECTION 3. Section 26-12, Hawaii Revised Statutes, is
- 9 amended to read as follows:
- 10 "\$26-12 Department of education. The department of
- 11 education shall be headed by an executive board to be known as
- 12 the board of education.
- 13 Under policies established by the board, the superintendent
- 14 shall administer programs of education and public instruction
- 15 throughout the State, including education at the primary and
- 16 secondary school levels, adult education, school library
- 17 services, health education and instruction (not including dental
- 18 health treatment transferred to the department of health),
- 19 special education and Title I funded programs at the
- 20 prekindergarten level, and such other programs as may be
- 21 established by law; provided that the department shall not

- 1 establish general education prekindergarten classrooms,
- 2 [including private partnership-funded-classrooms] and classrooms
- 3 to provide general education settings for children whose
- 4 individualized education programs require such placement;
- 5 provided further that the department may establish Title I-
- 6 funded prekindergarten classrooms. The department shall
- 7 collaborate with the executive office on early learning to
- 8 coordinate services for children who are placed through their
- 9 individualized education programs in a general education
- 10 prekindergarten setting in a classroom offered by the executive

- 12 policies established by the early learning board, the executive
- 13 office on early learning shall have administrative authority
- 14 over all state-funded prekindergarten programs, and private
- 15 partnership-funded prekindergarten programs in the public
- 16 schools, except for special education and Title I-funded
- 17 prekindergarten programs. The state librarian, under policies
- 18 established by the board of education, shall be responsible for
- 19 the administration of programs relating to public library
- 20 services and transcribing services for the blind.

1	The functions and authority exercised by the department
2	relating to state-funded prekindergarten programs, [private
3	partnership funded prekindergarten programs in the public
4	schools, and classrooms to provide general education settings
5	for children whose individualized education programs require
6	such placement, except for special education and Title I-funded
7	prekindergarten programs, shall be transferred to the executive
8	office on early learning; provided that the department shall
9	continue to provide, and have administrative authority over,
10	services generally provided to the schools excluding those
11	services related to curriculum, instruction, assessment, and
12	professional learning support, for any facility on a department
13	school campus at which the executive office on early learning
14	administers programs.
15	The functions and authority heretofore exercised by the
16	department of education (except dental health treatment
17	transferred to the department of health), library of Hawaii,
18	Hawaii county library, Maui county library, and the transcribing
19	services program of the bureau of sight conservation and work
20	with the blind, as heretofore constituted are transferred to the
21	public library system established by this chapter.

1 The management contract between the board of supervisors of 2 the county of Kauai and the Kauai public library association 3 shall be terminated at the earliest time after November 25, 4 1959, permissible under the terms of the contract and the provisions of this paragraph shall constitute notice of 5 6 termination, and the functions and authority heretofore exercised by the Kauai county library as heretofore constituted 7 8 and the Kauai public library association over the public 9 libraries in the county of Kauai shall thereupon be transferred 10 to the public library system established by this chapter. The management contracts between the trustees of the 11 12 library of Hawaii and the Friends of the Library of Hawaii, and 13 between the library of Hawaii and the Hilo library and reading 14 room association, shall be terminated at the earliest time after November 25, 1959, permissible under the terms of the contracts, 15 16 and the provisions of this paragraph shall constitute notice of 17 termination. 3	(6)	The incorporation of standards that are research-based
4		and developmentally-appropriate practices associated

- (A) Positive teacher-child interactions that shall be evaluated through observations conducted by the commission using a research-based tool at least twice a year, for the purposes of professional development; provided that the observations shall not be used for the purposes of teacher evaluation;
- (B) The early learning environment shall be assessed using a tool that measures its effectiveness and shall be conducted at least two times per school year by a certified observer who is employed or contracted by the commission; provided that the teaching staff shall use the assessment data and feedback to improve the quality of the learning environment; provided further that observations

2		development and shall not be used for the
3		purposes of teacher evaluation;
4	(C)	Use of individual child formative assessments
5		that are used for ongoing planning relating to
6		all areas of child development and learning
7		including cognitive, linguistic, social emotional
8		approaches to learning, and health and physical
9		development;
10	(D)	Family engagement in partnership with charter
11		schools, including conducting outreach for
12		enrollment and engagement of families in their
13		children's education in recognition of families'
14		role as their child's first and most important
15		teacher;
16	(E)	Alignment with the Hawaii early learning and
17		development standards, department standards,
18		state content and performance standards, and
19		general learner outcomes for grades kindergarten
20		to twelve to facilitate a seamless educational
21		experience for children;

I	(F')	Requirements that any teacher shall have
2		coursework in early childhood education pursuant
