A BILL FOR AN ACT

RELATING TO HIGHWAYS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the integrity of
- 2 Honoapiilani highway, the main access road to and from west
- 3 Maui, has been compromised due to negative impacts from climate
- 4 change, erosion, and inundation. The legislature recognizes
- 5 that any plan to relocate the existing highway will require a
- 6 close and vibrant partnership between the State and the county
- 7 of Maui.
- **8** The legislature further finds that in response to the
- 9 damaging effects that the business practices of fossil fuel
- 10 companies have had on the county of Maui in general and on
- 11 Honoapiilani highway in particular, the county has initiated a
- 12 lawsuit to seek compensation from fossil fuel companies to fund
- 13 the relocation of the Honoapiilani highway. The legislature
- 14 additionally finds that it is in the best interest of the
- 15 State's residents and visitors to enable the county of Maui to
- 16 directly use any funds realized from its lawsuit against fossil
- 17 fuel companies to relocate and maintain Honoapiilani highway as

- 1 a scenic coastal route, and to allow the State to direct its
- 2 funds primarily for extending the Lahaina bypass as an alternate
- 3 high-capacity thoroughfare for west Maui.
- 4 The legislature also finds that state revenues are severely
- 5 diminished because of the COVID-19 pandemic and that without
- 6 these partnerships, the State will be unable to improve the
- 7 transportation infrastructure of west Maui. Furthermore, the
- 8 legislature finds that to convey all of Honoapiilani highway to
- 9 the county of Maui is excessive and that a more limited
- 10 conveyance will facilitate quicker relocation and restoration of
- 11 critical areas.
- 12 Accordingly, the purpose of this Act is to convey ownership
- 13 of a portion of Honoapiilani highway from the State to the
- 14 county of Maui.
- 15 SECTION 2. The governor shall transfer the fee simple
- 16 ownership interest of route 30, Honoapiilani highway, from the
- 17 State to the county of Maui for use as a county highway, by
- 18 December 31, 2021. The department of transportation, in
- 19 conjunction with the county of Maui, shall identify the section
- 20 of Honoapiilani highway under threat of inundation and erosion

- 1 for transfer from the State to the county for purposes of
- 2 relocating the highway to protect the coastal scenic route.
- 3 SECTION 3. This Act shall take effect upon its approval.
