Section 92-5, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: 3 "(a) A board may hold a meeting closed to the public 4 pursuant to section 92-4 for one or more of the following 5 purposes: 6 To consider and evaluate personal information relating (1)7 to individuals applying for professional or vocational 8 licenses cited in section 26-9 or both: 9 (2) To consider the hire, evaluation, dismissal, or 10 discipline of an officer or employee or of charges 11 brought against the officer or employee, where 12 consideration of matters affecting privacy will be 13 involved; provided that if the individual concerned 14 requests an open meeting, an open meeting shall be 15 held; 16 (3) Notwithstanding the right of the individual concerned 17 in paragraph (2) to request an open meeting, to
