

A BILL FOR AN ACT

RELATING TO OFFENSES AGAINST PROPERTY RIGHTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaii Revised
- 2 Statutes contains numerous provisions aimed at addressing the
- 3 high number of vehicle thefts that occur on the island of Oahu.
- 4 Frequently, a stolen vehicle is recovered during the commission
- 5 of a crime or after it has been used to commit other crimes. In
- 6 many vehicle theft cases, the vehicle is recovered while being
- 7 operated or occupied by individuals who were not authorized to
- 8 operate or occupy the vehicle. However, law enforcement
- 9 officers may be unable to connect the actual theft of the
- 10 vehicle with a specific individual.
- 11 Current statutory provisions have been rendered ineffective
- 12 by state court rulings that require the State to prove that a
- 13 defendant operating or occupying a stolen vehicle knew that the
- 14 vehicle was stolen. In the great majority of cases, this
- 15 requires a confession from the defendant, which may be difficult
- 16 to obtain because defendants have the right to remain silent.

- 1 Thus, law enforcement is often hindered in meeting the burden of
- 2 proof needed to prosecute these cases.
- 3 Accordingly, the purpose of this Act is to establish the
- 4 offense of unauthorized control of propelled vehicle in the
- 5 second degree, which applies if a person recklessly or
- 6 negligently exerts unauthorized control over another's propelled
- 7 vehicle by operating the vehicle without the owner's consent or
- 8 by changing the identity of the vehicle without the owner's
- 9 consent.
- 10 SECTION 2. Chapter 708, Hawaii Revised Statutes, is
- 11 amended by adding a new section to part IV be appropriately
- 12 designated and to read as follows:
- 13 "§708- Unauthorized control of propelled vehicle in the
- 14 second degree. (1) A person commits the offense of
- 15 unauthorized control of a propelled vehicle in the second degree
- 16 if the person recklessly or negligently exerts unauthorized
- 17 control over another's propelled vehicle by operating the
- 18 vehicle without the owner's consent or by changing the identity
- 19 of the vehicle without the owner's consent.
- 20 (2) It is an affirmative defense to a prosecution under
- 21 this section that the defendant:

1	<u>(a)</u>	Received authorization to use the vehicle from an
2		agent of the owner where the agent had actual or
3		apparent authority to authorize such use; or
4	<u>(b)</u>	Is a lien holder or legal owner of the propelled
5		vehicle, or an authorized agent of the lien holder or
6		legal owner, engaged in the lawful repossession of the
7		propelled vehicle.
8	(3)	For the purposes of this section:
9	"Own	er" means the registered owner of the propelled vehicle
10	or the un	recorded owner of the vehicle pending transfer of
11	ownership	; provided that if there is no registered owner of the
12	propelled	vehicle or unrecorded owner of the vehicle pending
13	transfer	of ownership, "owner" means the legal owner.
14	"Pro	pelled vehicle" shall have the same meaning as in
15	section 7	08-836.
16	(4)	Unauthorized control of a propelled vehicle in the
17	second de	gree is a misdemeanor."
18	SECT	ION 3. Section 708-836, Hawaii Revised Statutes, is
19	amended t	o read as follows:
20	"§70	8-836 Unauthorized control of propelled vehicle[+] in
21	the first	degree. (1) A person commits the offense of

- 1 unauthorized control of a propelled vehicle in the first
- 2 <u>degree</u> if the person intentionally or knowingly exerts
- 3 unauthorized control over another's propelled vehicle by
- 4 operating the vehicle without the owner's consent or by changing
- 5 the identity of the vehicle without the owner's consent.
- 6 [(2) "Propelled vehicle" means an automobile, airplane,
- 7 motorcycle, motorboat, or other motor-propelled vehicle.
- 8 (2) It is an affirmative defense to a prosecution
- 9 under this section that the defendant:
- 10 (a) Received authorization to use the vehicle from an
- agent of the owner where the agent had actual or
- apparent authority to authorize such use; or
- 13 (b) Is a lien holder or legal owner of the propelled
- vehicle, or an authorized agent of the lien holder or
- legal owner, engaged in the lawful repossession of the
- propelled vehicle.
- 17 $\left[\frac{4}{3}\right]$ For the purposes of this section $\left[\frac{3}{7}\right]$ "owner":
- "Owner" means the registered owner of the propelled vehicle
- 19 or the unrecorded owner of the vehicle pending transfer of
- 20 ownership; provided that if there is no registered owner of the

- 1 propelled vehicle or unrecorded owner of the vehicle pending
- 2 transfer of ownership, "owner" means the legal owner.
- 4 motorcycle, motorboat, or other motor-propelled vehicle.
- 5 [(5)] (4) Unauthorized control of a propelled vehicle in
- 6 the first degree is a class C felony."
- 7 SECTION 4. This Act does not affect rights and duties that
- 8 matured, penalties that were incurred, and proceedings that were
- 9 begun before its effective date.
- 10 SECTION 5. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 6. This Act shall take effect upon its approval.
