A BILL FOR AN ACT

RELATING TO WITNESS FEES AND REIMBURSEMENTS IN CRIMINAL CASES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 621-7, Hawaii Revised Statutes, is
 amended to read as follows:

3 "**§621-7 Fees; criminal cases.** (a) [Every] Except as 4 provided in subsection (c), every witness legally required to 5 attend a state court or grand jury in any criminal case, other 6 than a public officer or employee, shall be entitled to \$20 for 7 each day's attendance and a reasonable mileage fee to be 8 established pursuant to rules adopted by the judiciary for each 9 mile actually and necessarily traveled on the ground each way, 10 including travel to and from the nearest airport when required 11 to travel from another island or from outside the State.

12 In addition to witness' fees, every witness[+] who attends 13 a state court from:

14 (1) [Who attends a state court from outside] Outside the
15 State shall be entitled to the actual round-trip cost
16 of plane travel, plus [\$200] \$250 per twenty-four-hour

1 (2)[Who attends a state court from any] Any island in the 2 State other than that on which the court holds session 3 shall be entitled to the actual round-trip cost of 4 plane travel, plus \$55 per twenty-four-hour day; 5 provided that when the witness is required to stay 6 overnight, the witness shall be entitled to an 7 additional [\$145] \$195 per twenty-four-hour day. 8 [These] Any per diem [payments] payment made pursuant to this 9 subsection shall cover all personal expenses, such as board and 10 lodging, and shall be computed on the basis of [quarter day] 11 quarter-day periods of time.

12 (b) Any police officer or other public officer or employee 13 (except the county attorney, prosecuting attorney, or deputy 14 county attorney or deputy prosecuting attorney), who attends a 15 state court as a witness from a district other than that in 16 which the court is holding session, shall be allowed the police 17 officer's, public officer's, or employee's travel cost and 18 mileage fees as provided in this section. A public officer or 19 employee, if not salaried, shall receive witness fees.

20 (c) Every expert witness legally required to attend a
21 state court or grand jury in any criminal case, other than a
