#### A BILL FOR AN ACT

RELATING TO VOTER REGISTRATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended
2	by adding a new section to part II to be appropriately
3	designated and to read as follows:
4	<u>§11- Applications for a driver's license or civil</u>
5	identification card. (a) Notwithstanding any law to the
6	contrary, an affidavit on an application for voter registration
7	shall be a part of any application associated with the issuance
8	of a driver's license under section 286-109 or a civil
9	identification card under section 286-301.
10	(b) An application for a driver's license or civil
11	identification card shall not be processed until the applicant
12	has:
13	(1) Been confirmed electronically as already a currently
14	registered voter;
15	(2) Applied on the application form to register to vote;
16	or



1	(3) Affirmatively declined on the application form to		
2	register to vote.		
3	(c) If an applicant for a driver's license or civil		
4	identification card is a currently registered voter, an		
5	application form shall serve to automatically update the		
6	applicant's voter registration residence address, mailing		
7	address, or name, as applicable. A notice to this effect shall		
8	be stated on any application form utilized by the examiner of		
9	drivers.		
10	(d) The examiner of drivers and the state department of		
11	transportation shall maintain current electronic database		
12	records indicating each driver's license or civil identification		
13	card holder's status as a registered voter, in addition to any		
14	other information referred to in subsection (e).		
15	(e) The examiner of drivers shall electronically transmit		
16	to the office of elections, on a real time basis, information		
17	required by this subsection for any applicant who is a currently		
18	registered voter or any applicant who is a United States citizen		
19	and has not affirmatively declined to register to vote. The		
20	information required for electronic transmittal includes an		
21	applicant's:

5 (b) The examiner of drivers shall not issue or renew any
6 driver's license using the driver's social security number on
7 the driver's license.

8 Statutes of limitations and other provisions of this (C) chapter notwithstanding, no driver's license or instruction 9 10 permit shall be issued or renewed under this section, where the examiner of drivers is notified by the district judge, traffic 11 violations bureaus of the district courts, or the judge of the 12 13 circuit court that the applicant has failed to respond to a 14 traffic citation or summons, or failed to appear in court after 15 an arrest for the violation of any traffic laws of a county, 16 this chapter or chapter 286G, 287, 290, 291, or 291C, or of any 17 motor vehicle insurance laws under article 10C of chapter 431, 18 or of any motorcycle or motor scooter insurance laws under 19 article 10G of chapter 431, and the same remains delinquent and 20 outstanding, or the applicant, has as of the time of the 21 application, failed to comply in full with all orders of the

1 court; provided that this subsection shall not apply to 2 outstanding and delinquent payments pursuant to chapter 291D; provided further that the district court with whose order an 3 4 applicant has failed to comply in full, may approve the issuance or renewal of a driver's license or instruction permit other 5 6 than a commercial driver's license upon conditions imposed by 7 the court for the satisfaction of the outstanding court order 8 and any other conditions as may be imposed by the court, if one 9 or more of the following conditions are met: 10 (1) The applicant is gainfully employed in a position that 11 requires driving and will be discharged if the 12 applicant is unable to drive; or 13 (2) The applicant has no access to alternative 14 transportation and therefore must drive to work; 15 provided further that if the applicant has failed to comply in 16 full with orders of the district court of more than one circuit, 17 the applicant shall obtain the approval of the district court of 18 each circuit in which the applicant has an outstanding court 19 order before a driver's license or instruction permit may be 20 issued or renewed under this subsection.

1 A driver's license or instruction permit issued or renewed 2 under this subsection shall be subject to immediate suspension 3 by the court upon the applicant's failure to remain in full 4 compliance with all conditions imposed by the court for the issuance or renewal of the driver's license or instruction 5 6 permit. The examiner of drivers may place an indication of 7 restriction upon a driver's license or instruction permit issued 8 or renewed under this subsection. Proof of financial 9 responsibility under section 287-20 shall not apply to the 10 issuance or renewal of driver's licenses or instruction permits 11 under this subsection.

12 (d) An application for a driver's license shall include
13 the information required under section 11-\_\_\_\_"

14 SECTION 3. Section 286-301, Hawaii Revised Statutes, is 15 amended to read as follows:

16 "[+]§286-301[+] Issuance of identification card or
17 temporary card. (a) To obtain an identification card from the
18 examiner of drivers, an individual shall complete an application
19 pursuant to section 286-303.

20 (b) The examiner of drivers, upon receipt of [the] an
21 application by any individual who is a resident or a temporary

1 resident of this State, shall issue an identification card to 2 that individual upon receipt of [any] an appropriate fee 3 established pursuant to section 286-309. 4 (C) The identification card shall be similar in size. 5 shape, and design to a driver's license, but shall not entitle 6 the individual to whom it is issued to operate a motor vehicle. 7 The issuance of an identification card pursuant to (d) 8 this section shall not place upon the State of Hawaii or any 9 agency any liability for the misuse or the acceptance of [the] 10 an identification card as valid identification, which shall be 11 left entirely to the discretion of any individual to whom [such] 12 an identification card is presented. 13 (e) An application for an identification card from the 14 examiner of drivers shall include the information required under 15 section 11- ." SECTION 4. Section 286-311, Hawaii Revised Statutes, is 16 17 amended by amending subsection (a) to read as follows: 18 "(a) [All] Except for the purposes of sections 11- , 19 286-109, and 286-301, information and records acquired by the 20 examiner of drivers under this part shall be confidential. All 21 information and records shall be maintained in an appropriate

1 form and in an appropriate office in the custody and under the 2 control of the examiner. The information shall be available 3 only to authorized individuals under [such] any restrictions as 4 the director shall prescribe. The examiner may dispose of any 5 application or identification card, or information or record 6 relating to the application or identification card, [which] that 7 does not include a social security number, without regard to chapter 94, whenever, in the examiner's discretion, retention of 8 9 the information or record is no longer required or practicable." 10 SECTION 5. Statutory material to be repealed is bracketed 11 and stricken. New statutory material is underscored. 12 SECTION 6. This Act shall take effect on January 1, 2022.

#### Report Title:

Office of Elections Package; DOT; Automatic Voter Registration; Driver's Licenses; Civil Identification Cards

#### Description:

Establishes automatic voter registration upon application for a driver's license or civil identification card, except when an applicant affirmatively declines on an application to register to vote. Requires the examiner of drivers to electronically transmit to the Office of Elections certain information associated with currently registered and newly registered voters. Requires accessibility of certain databases maintained or operated by the Department of Transportation or the counties.
