### A BILL FOR AN ACT

RELATING TO ELECTION PROCLAMATIONS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 11-91, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "S11-91 Proclamation. Not later than 4:30 p.m. on the
- 4 tenth day prior to the close of filing in elections involving
- 5 state offices the chief election officer shall issue an election
- 6 proclamation. In elections involving only county offices the
- 7 clerk shall issue the proclamation. In elections involving both
- 8 state and county offices the proclamation may be issued jointly.
- 9 The proclamation shall contain a statement of the [time and
- 10 places where, and the] purposes for which[7] the election is to
- 11 be held, and a designation of the offices and the terms thereof
- 12 for which candidates are to be nominated or elected. It may
- 13 also contain any other relevant matter including an offer of
- 14 rewards for the detection and conviction of offenders against
- 15 the election laws. The chief election officer or clerk shall
- 16 cause the election proclamation to be published at least once in

- 1 a newspaper of general circulation and not later than on the
- 2 tenth day prior to the close of filing."
- 3 SECTION 2. Section 11-92.1, Hawaii Revised Statutes, is
- 4 amended by amending subsection (a) to read as follows:
- 5 "(a) The [chief election officer] clerk shall issue a
- 6 proclamation listing all voter service centers and places of
- 7 deposit as may have been determined by the clerk as of the
- 8 proclamation date. The clerk shall make arrangements for the
- 9 rental or erection of suitable shelter for the establishment of
- 10 a voter service center whenever public buildings are not
- 11 available and shall cause these voter service centers to be
- 12 equipped with the necessary facilities for lighting,
- 13 ventilation, and equipment needed for elections on any island.
- 14 This proclamation may be issued jointly with the proclamation
- 15 required in section 11-91."
- 16 SECTION 2. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
