RELATING TO SECTION 711-1109, HAWAII REVISED STATUTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 711-1109, Hawaii Revised Statutes, is 2 amended as follows:

- 10 torture, torment, beating, or starving of any animal;
- 11 (b) Deprives a pet animal of necessary sustenance or
- causes [such] that deprivation;
- 13 (c) Mutilates, poisons, or kills without need any animal
- other than insects, vermin, or other pests; provided
- that the handling or extermination of any insect,
- vermin, or other pest is conducted in accordance with

- 8 SECTION 2. This Act does not affect rights and duties that
- 9 matured, penalties that were incurred, and proceedings that were
- 10 begun before its effective date.

- 12 and stricken. New statutory material is underscored.
- 13 SECTION 4. This Act shall take effect upon its approval.
