RELATING TO THE TRANSFER OF NON-AGRICULTURAL PARK LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 2 of Hawaii 2003 (Act 90), was enacted to transfer certain non-3 agricultural park lands from the department of land and natural 4 resources to the department of agriculture. While three hundred 5 parcels consisting of approximately nineteen thousand acres have 6 been transferred over the past seventeen years, many parcels 7 have not been transferred. 8 The legislature further finds that many state pasture 9 lessees have requested the department of land and natural 10 resources to transfer their leases to the department of
