

### A BILL FOR AN ACT

RELATING TO FISHING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 188-22.6, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[+] §188-22.6[+] Designation of community-based
- 4 subsistence fishing area. (a) The department of land and
- 5 natural resources may designate community-based subsistence
- 6 fishing areas and carry out fishery management strategies for
- 7 such areas, through administrative rules adopted pursuant to
- 8 chapter 91, for the purpose of reaffirming and protecting
- 9 fishing practices customarily and traditionally exercised for
- 10 purposes of native Hawaiian subsistence, culture, and
- 11 religion [-]; provided that the designation shall be approved by
- 12 at least fifty per cent of the residents of the affected
- 13 community.
- 14 (b) Proposals may be submitted to the department of land
- 15 and natural resources for the department's consideration. The
- 16 proposal shall include:

2		proposal;
3	(2)	The charter of the organization or group;
4	(3)	A list of the members of the organization or group;
5	(4)	A description of the location and boundaries of the
6		marine waters and submerged lands proposed for
7		designation;
8	(5)	Justification for the proposed designation including
9		the extent to which the proposed activities in the
10		fishing area may interfere with the use of the marine
11		waters for navigation, fishing, and public recreation
12		and
13	(6)	A management plan containing a description of the
14		specific activities to be conducted in the fishing
15		area, evaluation and monitoring processes, methods of
16		funding and enforcement, and other information
17		necessary to advance the proposal.
18	Proposals	shall meet community-based subsistence needs [and],
19	judicious	fishery conservation and management practices [+] , and
20	be approve	ed by at least fifty per cent of the residents of the
21	affected o	community.
