Section 302A-833, Hawaii Revised Statutes, is 13 amended by amending subsection (b) to read as follows: 14 The revolving fund may be used by the department of 15 education for any and all of the purposes of teachers' housing, 16 including the planning, construction, maintenance, and operation 17 of teachers' housing, including a teacher housing facility on a 18 public school campus, as well as for the salaries of the 19 necessary personnel in charge thereof." 20 SECTION 3. Statutory material to be repealed is bracketed

and stricken. New statutory material is underscored.
