

### A BILL FOR AN ACT

RELATING TO DIGITAL MEDIA.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 489J, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§489J- Contracts for digital media accounts;
- 5 prohibited provisions. (a) This section shall apply to all
- 6 contracts entered into, modified, or renewed on or after July 1,
- 7 2021. No contract shall prohibit, limit, or restrict the
- 8 transfer of a person's digital media account, upon that person's
- 9 death, to any devisee or devisees designated by the person's
- 10 will, or, if none, to any heir or heirs of the person pursuant
- 11 to the statutes of intestate succession.
- 12 (b) For the purposes of this section, "digital media
- 13 account" shall have the same meaning as defined in section
- 14 560:2-B."
- 15 SECTION 2. Chapter 560, Hawaii Revised Statutes, is
- 16 amended by adding a new part to article II to be appropriately
- 17 designated and to read as follows:

2	§560:2-A Applicability. This part is applicable to all
3	contracts entered into, renewed, or modified on or after July 1,

5	§560:2-B Definitions. For the purposes of this part,
6	"digital media account" means any account established for the
7	purpose of playing, downloading, storing, or organizing digital
8	media including music, video, photographs, audiobooks, audio
9	performances, or games; any account identification and password
10	information necessary to access the account; any digital media
11	content stored electronically under the account; and any use
12	license for any digital media stored electronically under the
13	account.
14	§560:2-C Notice; maintenance of digital media account.
15	Upon receipt of proof of death as provided under section
16	560:1-107 from the personal representative of a decedent's
17	estate within days of the decedent's death, a person or
18	entity shall not terminate any digital media account maintained
19	by the person or entity for the decedent, or destroy or dispose
20	of any digital media content of the decedent stored
21	electronically by the person or entity, except in the case of a

- 3 §560:2-D Access to decedents' digital media account. To
- 4 obtain the identification and password information necessary to
- 5 access a digital media account held at the time of death by the
- 6 decedent, the personal representative of the estate shall
- 7 provide any person or entity with whom the decedent held the
- 8 digital media account with:
- 9 (1) A written request for the identification and password
- information necessary for such access, accompanied by
- proof of death as provided under section 560:1-107,
- and a certified copy of appointment as personal
- representative of the estate; or
- 14 (2) An order of a court having probate jurisdiction over
- the decedent's estate.
- 16 Upon receipt, the person or entity shall provide the personal
- 17 representative with the identification and password information
- 18 necessary to access the digital media account of the decedent.
- 19 The personal representative shall transfer such information to
- 20 the decedent's devisee or devisees as determined by will, or, if

- 3 §560:2-E Descent of digital media account. (a) Any
- 4 digital media account of a decedent shall pass to the devisee or
- 5 devisees designated by the decedent's will, or, if none, shall
- 6 descend and be divided among the decedent's heir or heirs in
- 7 accordance with the statutes of intestate succession.
- 8 (b) Any devisee or heir inheriting any part of a digital
- 9 media account shall be subject to the same terms and conditions
- 10 as were applicable to the decedent at the time of death."
- 11 SECTION 3. This Act does not affect rights and duties that
- 12 matured, penalties that were incurred, and proceedings that were
- 13 begun before its effective date.
- 14 SECTION 4. In codifying the new sections added by section
- 15 2 of this Act, the revisor of statutes shall substitute
- 16 appropriate section numbers for the letters used in designating
- 17 the new sections in this Act.
- 18 SECTION 5. New statutory material is underscored.
- 19 SECTION 6. This Act shall take effect on July 1, 2021.
