A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that the department of
3	education is the only public education system in the country
4	that is wholly state funded. This singular funding status has
5	resulted in the department of education facing unique challenges
6	to utilizing funds provided by the federal government to offset
7	the negative economic impacts of the COVID-19 pandemic.
8	The legislature also finds that the states that receive
9	certain federal funds, including moneys from the Elementary and
10	Secondary School Emergency Relief Funds established by the
11	Coronavirus Aid, Relief, and Economic Security Act, Public
12	Law 116-136 (CARES Act), and the Coronavirus Response and Relief
13	Supplemental Appropriations Act, 2021, Public Law 116-260 (CRRS
14	Appropriations Act), are required to assure that they will
15	maintain support for education programs during fiscal years
16	2019-2020 and 2020-2021 by meeting certain benchmarks.

- 1 The legislature further finds that the CARES Act created
- 2 the federal Education Stabilization Fund. The State, through
- 3 the department of education, must comply with the provisions of
- 4 the federal Education Stabilization Fund as set forth in
- 5 sections 18006, 18008, 315, and 317 of the CARES Act in order to
- 6 receive and expend CARES Act and CRRS Appropriations Act moneys.
- 7 In accepting and expending federal CARES Act and CRRS
- 8 Appropriations Act moneys, it is the legislature's intent that
- 9 the department of education employees who are subject to a
- 10 collective bargaining agreement continue to receive their pay.
- 11 The legislature also finds that the State, through the
- 12 department of education, must also comply with the "maintenance
- 13 of effort" provisions set forth in section 18008 of the CARES
- 14 Act. These provisions require funding for public education to
- 15 be maintained at the same funding levels as in fiscal years
- 16 2017, 2018, and 2019, for those funds that are part of the CARES
- 17 Act, and at a proportional funding level for the CRRS
- 18 Appropriations Act.
- 19 The legislature declares that it does not support any
- 20 attempts by the superintendent of education to seek a waiver
- 21 from the Secretary of Education.

16	State from the CARES Act and CRRS Appropriations Act, the sum of

18	year 2020-2021 to offset any budget reductions that have been
19	identified or proposed by the department of education and the

7	secondary school emergency relief fund moneys received by the

9	\$104,175,932 or so much thereof as may be necessary for fiscal		
10	year 2021-2022 and the same sum or so much thereof as may be		
11	necessary for fiscal year 2022-2023 to offset any budget		
12	reductions that have been identified or proposed by the		
13	department of education and the governor that would result in		
14	the reduction of personnel who are subject to a collective		
15	bargaining agreement executed pursuant to chapter 89, Hawaii		
16	Revised Statutes, and who are employed at the school level,		
17	including any budget reduction that results in a layoff,		
18	furlough, or pay reduction; provided that:

Description:

Makes an emergency appropriation for fiscal year 2020-2021 from elementary and secondary school emergency relief fund (ESSER funds) moneys received by the State from the CARES Act and CRRS Appropriations Act to offset any budget reductions that are identified or proposed by the department of education and the governor that would result in the reduction of personnel who are subject to a collective bargaining agreement pursuant to chapter 89, HRS, and who are employed at the school level, including any budget reduction that results in a layoff, furlough, or pay reduction. Requires BOE and superintendent of education to certify in writing that BOE, superintendent, and DOE agree to certain conditions, including that the funds appropriated shall be used only for salaries and wages of officers and employees who are subject to a collective bargaining agreement and are employed at the school level. Makes an appropriation for fiscal years 2021-2022 and 2022-2023 from the same source of funding and with the same conditions. Effective 7/1/2050. (HD2)
