# A BILL FOR AN ACT

RELATING TO FARM TO SCHOOL PROCUREMENT.

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that building farm to 2 school connections can improve student access to healthy, local 3 foods, provide numerous public health benefits, and contribute to the local agricultural industry. The National Farm to School 4 Network reports that increasing local food procurement in 5 schools provides economic benefits to school districts by 6 increasing student and teacher meal participation and decreasing 7 school meal program costs. 8

9 The legislature also finds that local food procurement 10 provides economic benefits to local food systems by providing a 11 long-term revenue stream for farmers and other food producers, promoting market diversification, and increasing income and 12 13 economic growth opportunities for individual farmers. The 2008 14 Farm Bill directed the Secretary of Agriculture to encourage 15 schools to purchase unprocessed locally grown and locally raised 16 products "to the maximum extent practicable and appropriate." The Secretary was also instructed to allow child nutrition 17

program operators to use a "geographic preference" when
procuring unprocessed locally grown and locally raised
agricultural products.

The purpose of this Act is to require the department of 4 5 education to adopt rules for the procurement of goods and services related to the administration of food programs at 6 7 public schools that incorporate a geographic preference for unprocessed locally grown and locally raised agricultural 8 products. This Act will thereby facilitate the increase of 9 10 locally grown and locally raised food products from Hawaii farmers, ranchers, and food producers and allow school complexes 11 12 to regionalize their menus.

13 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is 14 amended by adding a new section to be appropriately designated 15 and to read as follows:

### 16 "§302A- Food program; procurement; geographic

17 preference; exemption. (a) The department shall adopt rules 18 pursuant to chapter 91 for the procurement of goods and services 19 related to the administration of food programs at public schools 20 that incorporate a geographic preference for unprocessed locally 21 grown and locally raised agricultural products.
