# A BILL FOR AN ACT

RELATING TO EMERGENCY WORKERS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 707-700, Hawaii Revised Statutes, is 2 amended by amending the definition of "emergency worker" to read 3 as follows: ""Emergency worker" means any: 4 Law enforcement officer[7]; including any police 5 (1) officer  $[\tau]$ ; public safety officer  $[\tau]$ ; parole or probation officer[7]; or any other officer of any 7 8 county, state, federal, or military agency authorized 9 to exercise law enforcement or police powers; 10 (2) Firefighter, emergency medical services personnel, 11 emergency medical technician, ambulance crewmember, 12 Hawaii state on-scene coordinator, or any other 13 emergency response personnel; Member of the Hawaii National Guard on any duty or 14 (3) 15 service done under or in pursuance of an order or call 16 of the governor or the President of the United States 17 or any proper authority;

19		(B) Emergency dispatcher; or
20		(C) Other telecommunications dispatch personnel

1	terminal, uses multiple robust lifesaving
2	procedures and technologies to obtain critical
3	information from the caller, analyzes the
4	information given and, from specialized mapping
5	systems, sends the appropriate and closest
6	available emergency unit, and communicates the
7	best course of action for the caller to take
8	before the arrival of the field first responder.
9	As used in this paragraph, "working in the field"
10	means a telecommunications dispatcher that is
11	performing official work functions at an approved
12	location other than the person's central workplace
13	where their official work functions are normally
14	performed."
15	SECTION 2. This Act does not affect rights and duties that
16	matured, penalties that were incurred, and proceedings that were
17	begun before its effective date.
18	SECTION 3. Statutory material to be repealed is bracketed
19	and stricken. New statutory material is underscored.
20	SECTION 4. This Act shall take effect on July 1, 2050.
