BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 210D-11, Hawaii Revised Statutes, is

4	Grants shall be made for amounts not to exceed \$100,000 for each
5	applicant. Applications for grants shall be made to the
6	department and contain such information as the department shall

9	(1) The grant shall be used exclusively for community-

JUSTIFICATION SHEET

DEPARTMENT: Business, Economic Development, and Tourism

TITLE: A BILL FOR AN ACT RELATING TO THE HAWAII COMMUNITY-BASED ECONOMIC DEVELOPMENT TECHNICAL AND FINANCIAL ASSISTANCE PROGRAM.

PURPOSE: Expands the eligibility of organizations that can receive Community-based Economic Development (CBED) technical assistance from not just community-based organizations (nonprofits), but also includes businesses, particularly those that currently have CBED loans or may apply for a CBED loan in the future.

MEANS: Amend section 210D-11, Hawaii Revised Statutes.

JUSTIFICATION: Technical assistance is an important component of community-based economic development. CBED technical assistance should support not only community-based organizations (non-profits) to be successful in their missions, but also businesses (for profits) including recipients of CBED microloans. Expanding those organizations eligible for CBED technical assistance will allow the Department of Business, Economic Development, and Tourism (DBEDT) to better assist in the success and viability of these organizations.

> Impact on the public: These amendments will provide greater opportunity for businesses to participate in the CBED program as regards technical assistance. It is particularly important to support CBED micro-loan recipients with technical assistance to be successful.

> Impact on the department and other agencies: Will enable DBEDT's CBED program to be more responsive in addressing community-based
