TITLE:

A BILL FOR AN ACT RELATING TO THE HAWAII FILM AND CREATIVE INDUSTRIES DEVELOPMENT

SPECIAL FUND.

PURPOSE:

Expand the funding sources and the authorized uses of the Hawaii Film and Creative Industries Development Special Fund.

MEANS:

Amend section 201-113, Hawaii Revised Statutes.

JUSTIFICATION:

Act 228, Session Laws of Hawaii (SLH) 2019, renamed the Hawaii television and film development special fund as the creative film and media development special fund, and amended the uses of the fund to support creative intellectual property, film and media funding support within the Department of Business, Economic Development, and Tourism.

This bill would serve to clarify language in Act 228, SLH 2019, to add an expenditure ceiling of \$500,000, to begin implementation of the program as outlined in Act 228, SLH 2019, and expand sources of funding to include grants, revenues, rents, fees and charges collected by the department.

An expenditure ceiling is necessary in order to expend what is collected from other revenue sources and allow the Department to effectuate the Act.
