A BILL FOR AN ACT

RELATING TO SERVICES FOR KUPUNA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. In 2012, the legislature established in statute
2	the kupuna care program within the executive office on aging to
3	provide long-term services and supports to address the needs of
4	Hawaii's kupuna to age in their own homes. The program is
5	implemented through the area agencies on aging in each county.
6	The program offers two service options: traditional service
7	delivery through contracted providers or participant-directed
8	services and supports.
9	In 2017, the legislature established the kupuna caregivers
10	program in the executive office on aging to focus on working
11	caregivers and provide assistance to enable them to remain in
12	the workforce. The county area agencies on aging implement and
13	execute the kupuna caregivers program. For the kupuna
14	caregivers program, the qualified caregiver must work at least
15	30 hours per week and is awarded \$70 per day paid to the
16	contracted provider with the area agency on aging and providing
17	care to the care recipient. If additional services are needed

- 1 for the care recipient, kupuna care services are also provided.
- 2 In 2019, the Legislature modified the amount provided to
- 3 caregivers to \$210 per week to allow provider agencies more
- 4 flexibility to increase the number of caregivers receiving
- 5 services. Due to the COVID-19 pandemic in 2020, many caregivers
- 6 lost their jobs and contracted service providers either closed
- 7 or decreased their services. This increased the burden on
- 8 caregivers and their caregiving duties. With the uncertainty of
- 9 the State's economic situation and when businesses will be able
- 10 to recover, caregivers and service have been forced to develop a
- 11 "new normal." To give more flexibility to the kupuna caregivers
- 12 program, the executive office on aging recommends that the area
- 13 agencies on aging be allowed to have more options to better
- 14 serve kupuna and their caregivers.
- The purpose of this Act is to amend chapter 349, part II,
- 16 entitled kupuna care and caregiver support services, Hawaii
- 17 Revised Statutes, to allow for qualified caregivers to work less
- 18 than 30 hours a week or be unemployed during a declared state of
- 19 emergency, add the definition of a financial management service
- 20 provider, and add traditional services and kupuna caregiver-
- 21 directed services to the kupuna care program.
- 22 SECTION 2. Section 349-16, Hawaii Revised Statutes, is
- 23 amended to read as follows:

1 "[+]\$349-16]+] Definitions. Unless the context clearly 2 requires a different meaning, when used in this part: 3 "Activities of daily living" means the following activities 4 that individuals perform as a part of daily living: eating, 5 dressing, bathing, toileting, transferring in and out of a bed 6 or chair, and walking. 7 "Adult day care" means personal care for dependent elders 8 in a supervised, protective, and congregate setting during some 9 portion of a day. Services offered in conjunction with adult 10 day care include social and recreational activities, training, 11 and counseling. "Aging and disability resource centers" means an entity 12 13 established by the State as part of the state system of long-14 term care, serving as a highly visible and trusted source where 15 people of all incomes and ages can get information on the full 16 range of long-term support options, and a single point of entry 17 for access to public long-term support programs and benefits. 18 "Area agency on aging" means an agency designated by the executive office on aging to develop and administer the area 19 20 plan for a comprehensive and coordinated system of aging 21 services.

1	"Assisted transportation" means assistance and		
2	transportation, including escort, for a person who has cognitive		
3	or physical difficulties using regular vehicular transportation.		
4	"Attendant care" means standby assistance, supervision, or		
5	cues, including verbal prompts for medication, bathing, eating,		
6	grooming, and dressing, and may include other activities to help		
7	maintain the independence of an individual at home. "Attendant		
8	care" does not include physical contact in support, including		
9	but not limited to weight-bearing assistance with transfers,		
10	washing, bathing, and dressing.		
11	"Care coordination" means a person-centered, assessment-		
12	based, interdisciplinary approach to integrating health care and		
13	social support services that are tailored to an individual's		
14	needs and goals across all care services.		
15	"Care recipient" means an individual who:		
16	(1) Is a citizen of the United States or a qualified		
17	alien; provided that for the purposes of this		
18	paragraph, "qualified alien" means a lawfully admitted		
19	permanent resident under the Immigration and		
20	Nationality Act;		
21	(2) Is sixty years of age or older;		

1	(3)	Is not covered by any comparable government or private
2		home- and community-based care service, except or
3		excluding kupuna care services;
4	(4)	Does not reside in a long-term care facility, such as
5		an intermediate care facility, assisted living
6		facility, skilled nursing facility, hospital, foster
7		family home, community care foster family home, adult
8		residential care home, or expanded adult residential
9		care home; and
10	(5)	Has impairments of at least:
11	(A)	Two activities of daily living;
12	(B)	Two instrumental activities of daily living;
13	(C)	One activity of daily living and one
14		instrumental activity of daily living; or
15	(D)	Substantive cognitive impairment requiring
16		substantial supervision because the individual
17		behaves in a manner that poses a serious health
18		or safety hazard to the individual or another
19		person.
20	"Case	e management" means assistance either in the form of
21	access or	care coordination in circumstances where an individual
22	is experie	encing diminished functioning capacities, personal
23	conditions	s, or other characteristics that require the provision

1 of services by formal service providers or family caregivers. 2 Activities of case management may include assessing needs, 3 developing care plans, authorizing and coordinating services 4 among providers, and providing follow-up and reassessment, as 5 required. 6 "Chore" means assistance such as heavy housework, yard 7 work, or sidewalk maintenance for a person. "Coach" means an individual who: 8 9 (1) Helps the care recipient understand the program of 10 participant-directed services and support; 11 Develops and implements a spending plan to describe (2) 12 how the care recipient will spend the care recipient's 13 budget; and 14 Evaluates whether the participant-directed service and (3) 15 support program is meeting the care recipient's needs. 16 (4)Assists care recipient and caregiver with enrollment 17 into programs and completing necessary forms, 18 including but not limited to, state and federal tax 19 forms, privacy and confidentiality forms, criminal 20 background checks, financial management forms, 21 employer and employee related forms, and forms 22 requested by the executive office on aging.

1 "Family caregivers" means a spouse, adult child, other 2 relative, partner, or friend who has a personal relationship 3 with, and provides a broad range of unpaid assistance for an 4 older adult with a chronic or disabling condition. 5 "Financial management service provider" means a service 6 provider who is a fiscal agent and is responsible for financial 7 payments on behalf of the care recipient enrolled in a 8 participant-directed or kupuna caregiver-directed program. 9 "Home-delivered meals" means a meal provided to a care **10** recipient in the care recipient's place of residence; provided 11 that the meal is served in a program administered by the 12 executive office on aging or an area agency on aging and meets 13 all of the requirements of the Older Americans Act of 1965, as 14 amended, and all state and local laws. 15 "Homemaker [services]" means services that provide 16 assistance with preparing meals, shopping for personal items, 17 managing money, using the telephone, or performing light 18 housework. 19 "Instrumental activities of daily living" means the 20 following instrumental activities that individuals perform as a

part of daily living: preparing meals, shopping for personal

items, medication management, managing money, using the

2 housework, and making use of available transportation. 3 "Kupuna care core services" means services consisting of: 4 (1)Adult day care; 5 (2) Attendant care; 6 (3) Case management; 7 (4)[Chores; Chore; 8 (5) Homemaker [services]; 9 (6) Home-delivered meals; 10 (7) Personal care; 11 (8) Transportation; or 12 (9) Assisted transportation. 13 "Personal care" means personal assistance, standby 14 assistance, supervision, or cues. 15 "Person-centered planning" means a process, directed by the 16 care recipient, intended to identify the strengths, capacities, 17 preferences, needs, and desired outcomes of the care recipient. 18 "Person-centered support plan" or "support plan" means a 19 plan developed by a care recipient [with the assistance of a 20 coach] and the recipient's qualified caregiver that [allows] 21 identifies the needs of the care recipient [to establish the 22 goals, skills, and knowledge necessary to work toward the 23 desired outcomes and lays out practical steps toward the

5	"Qualified caregiver" means an individual who meets the			
6	following requirements:			
7	(1)	Provides care for a care recipient; and		
8	(2)	Is employed at least thirty hours per week by one or		
9		more employers $[-]$, or has reduced hours or is		
10		unemployed during a declared state of emergency.		
11	"Respite care" means services that offer temporary,			
12	substitute supports, or living arrangements for care recipients			
13	to provide a brief period of rest to qualified caregivers.			
14	"Respite	care" includes:		
15	(1)	In-home respite (personal care, homemaker services,		
16		and other in-home respite);		
17	(2)	Respite provided by attendance of the care recipient		
18		at a nonresidential program;		
19	(3)	Institutional respite provided by placing the care		
20		recipient in an institutional setting such as a		
21		nursing home for a short period of time as a respite		
22		service to the caregiver; and

1 Any combination of services to assist the caregiver as (4)2 deemed appropriate by the area agency on aging. 3 "Service provider" means an entity that has all required 4 licenses or certificates, and is registered as a business entity 5 in the State. 6 "Transportation" means transportation from one location to 7 another with a vehicle and does not include any other activity." 8 SECTION 3. Section 349-18 Hawaii Revised Statutes, is 9 amended to read as follows: 10 "[+]\$349-18[+] Kupuna caregivers program. (a) 11 executive office on aging may establish the kupuna caregivers 12 program. The program shall provide assistance to a qualified 13 caregiver who meets the requirements of this section. 14 (b) The program shall be coordinated and administered by 15 the executive office on aging and implemented through the area 16 agency on aging. The executive office on aging shall develop 17 and implement a plan to maximize the number of caregivers served 18 by the program. 19 (c) The kupuna caregivers program shall be delivered 20 through two distinct service options: traditional service 21 delivery or kupuna caregiver-directed services (kupuna

caregiver-directed services), based on an support plan for each

3	(1)	Traditional service delivery shall be through a	
4		service provider organization or person who provides

10		needs that have been identified in the care

12	(2)	Kupuna caregiver-directed services shall address the	
13		care recipient's assessed needs and allow for the	
14		qualified caregiver to remain in the workforce. The	
15		care recipient and qualified caregiver shall have	
16		shared decision-making authority over the budgeted	
17		dollar amount to purchase and manage the needed	
18		services and supports. Kupuna caregiver-directed	
19		services shall provide the care recipient and	
20		caregiver with a coach to assist the care recipient	
21		with enrollment into the kupuna caregiver-directed	
22		program to maintain independence and a quality living	
23		experience in the community, and assist the caregiver

Executive Office on Aging; Kupuna Care; Kupuna Caregivers

Description:

Adds kupuna caregiver-directed services to kupuna caregivers program. Includes financial management service provider and additional duties for the coach. Allows for qualified caregivers to work less than 30 hours a week or be unemployed during a declared state of emergency.

TITLE:

A BILL FOR AN ACT RELATING TO SERVICES FOR

KUPUNA.

PURPOSE:

Amend work eligibility requirement during a Governor proclaimed state of emergency and add kupuna caregiver-directed services as an option in the kupuna caregivers program.

MEANS:

Amend sections 349-16 and 349-18, Hawaii

Revised Statutes.

JUSTIFICATION:

During the Governor's declared state of emergency many working caregivers are now unemployed and ineligible for the kupuna caregivers program based on the program's minimum work week requirement of 30 hours a week. Additionally, qualified caregivers are limited to only using service providers that are contracted by the county area agencies on aging. Due to state and county COVID-19 mandates and CDC guidelines for social distancing these providers have either closed or provide limited service capacity. Adding kupuna caregivers-directed services to the list of services offered under the kupuna caregivers program will provide flexibility to the county area agencies on aging and provide caregivers an additional option of services for their care recipient.

The kupuna caregivers-directed services shall include a financial management service provider, contracted by the Executive Office on Aging, who is responsible for financial payments on behalf of participants enrolled in the kupuna caregivers-directed program. The role of the coach is expanded to also include assistance with enrollment into the kupuna caregivers program and completing necessary forms.

Impact on the public:

Adding kupuna caregivers-directed services to the list of services offered under the kupuna caregivers program will provide flexibility to the county area agencies on aging and provide caregivers an additional option of services for their care recipient. Qualified caregivers, and more importantly their care recipients enrolled in the kupuna caregivers program, will continue to receive these services.

Impact on the department and other agencies:
The Executive Office on Aging will provide
programmatic and administrative guidance to
the county area agencies on aging related to
implementing kupuna caregivers-directed
services as an additional option under the
list of services for the kupuna caregivers
program.
