## HOUSE CONCURRENT RESOLUTION

REQUESTING THE UNIVERSITY OF HAWAII SCHOOL OF NURSING AND DENTAL HYGIENE TO CONVENE A WORKING TO CONDUCT AN ANALYSIS OF ADVANCED PRACTICE REGISTERED NURSES AND PHYSICIAN ASSISTANTS.

WHEREAS, the Legislature recognizes that there is a 1 physician shortage in the State, which often leaves rural 2 3 communities with challenges to health care access; and 4 5 WHEREAS, the Legislature is currently looking at different legislation to expand the scope of practice for advanced 6 7 practice registered nurses and physician assistants; and 8 9 WHEREAS, according to the Hawaii State Center for Nursing, since 2009, the Legislature has passed twenty-two laws related 10 to the scope of practice of advanced practice registered nurses; 11 12 and 13 WHEREAS, the 2021 Legislature has or is considering five 14 15 measures related to expanding the scope of practice for advanced practice registered nurses in a variety of ways in Hawaii; and 16 17 18 WHEREAS, it is challenging to expand the scope of practice for advanced practice registered nurses and physician assistants 19 20 without a holistic view of what their scope of practice could 21 and should be in Hawaii; and 22 23 WHEREAS, there is a need to make clear distinctions to 24 understand the differences between physicians, advanced practice 25 registered nurses, and physician assistants and what each 26 profession's scope of practice in Hawaii should be; now, therefore, 27 28 29 BE IT RESOLVED by the House of Representatives of the Thirty-first Legislature of the State of Hawaii, Regular Session 30





of 2021, the Senate concurring, that the University of Hawaii 1 School of Nursing and Dental Hygiene is requested to conduct an 2 analysis of advanced practice registered nurses and physician 3 assistants; and 4 5 BE IT FURTHER RESOLVED that in its analysis, the University 6 of Hawaii School of Nursing and Dental Hygiene is requested to 7 8 include the following: 9 The full scope of practice for advanced practice 10 (1) registered nurses and physician assistants based on 11 national professional guidelines; 12 13 The distinctions between the educational training and 14 (2) scope of practice between physicians, advanced 15 practice registered nurses, and physician assistants; 16 17 An examination of potential scope of practice 18 (3) limitations for advanced practice registered nurses 19 and physician assistants in the Hawaii Administrative 20 Rules; and 21 22 (4) A comparative study of how Hawaii differs from other 23 states regarding the scope of practice for advanced 24 practice registered nurses and physician assistants; 25 26 and 27 BE IT FURTHER RESOLVED that the University of Hawaii School 28 29 of Nursing and Dental Hygiene is requested to submit a report of its findings to the Legislature no later than twenty days prior 30 to the Regular Session of 2022; and 31 32 33 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Governor, Lieutenant 34 Governor, and Dean of the University of Hawaii School of Nursing 35 and Dental Hygiene. 36
