HOUSE CONCURRENT RESOLUTION

AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT NAPILI 2 AND 3, LAHAINA, MAUI, FOR THE EXISTING WALKWAY, AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON.

WHEREAS, the Board of Land and Natural Resources approved 1 the issuance of a sixty-five-year term, non-exclusive easement 2 to Napili Kai, Ltd. under Grant of Non-Exclusive Easement No. S-3 5998 (GL5998) dated October 25, 2010, for the existing walkway 4 stairs, shower station, concrete pier block remnants, and 5 landscaping purposes on state lands fronting the property 6 7 identified as Tax Map Keys: (2) 4-3-002:026, 027, & 028, Napili 8 2 and 3, Lahaina, Maui; and

10 WHEREAS, at the time GL5998 was issued, the state lands 11 affected by the non-exclusive easement had not been identified 12 as state submerged lands; and

14 WHEREAS, around September 2016, Napili Kai, Ltd. submitted 15 an application for a shoreline certification in relation to the 16 consolidation/re-subdivision of its lots; and

18 WHEREAS, a site inspection conducted on November 2, 2016, 19 by the Department of Accounting and General Services' Survey 20 Division and staff of the Department of Land and Natural 21 Resources revealed that a portion of the existing walkway was on 22 state submerged lands outside of the encroachment area covered 23 by GL5998, with the walkway encroachment then estimated to total 24 140 square feet, more or less; and

26 WHEREAS, Napili Kai, Ltd. stated that the existing walkway 27 had not been altered since its construction, and the reason for 28 the discrepancy in the non-exclusive easement description under 29 GL5998 was unclear; and

2 WHEREAS, it therefore became necessary to increase the 3 encroachment area under the non-exclusive easement by 140 square 4 feet, more or less; and 5 WHEREAS, at its meeting of May 26, 2017, under agenda item 6 7 D-3, the Board of Land and Natural Resources approved staff's 8 recommendation to amend GL5998 by increasing the non-exclusive 9 easement encroachment area by 140 square feet, more or less, subject to confirmation by the Department of Accounting and 10 General Services' Survey Division, and payment by Napili Kai, 11 Ltd. for a new appraisal to determine the fair market value of 12 13 the additional encroachment area and for the value so determined; and 14 15 16 WHEREAS, the Department of Land and Natural Resources' 17 Office of Conservation and Coastal Lands had no objections to the proposed amendment of GL5998 to increase the non-exclusive 18 easement encroachment area; and 19 20 WHEREAS, the Department of Accounting and General Services' 21 Survey Division confirmed the total encroachment area to be 142 22 23 square feet and an appraisal determined the fair market value of an non-exclusive easement for the additional encroachment area 24 25 to be \$4,200, which Napili Kai, Ltd. paid in full to the Department of Land and Natural Resources in February 2019; and 26 27 28 WHEREAS, amending GL5998 to include the additional 29 encroachment area was subsequently determined to be problematic 30 because GL5998 was not issued as a submerged lands easement; and 31 32 WHEREAS, section 171-53, Hawaii Revised Statutes, requires 33 the prior approval of the Governor and prior authorization of the Legislature by concurrent resolution to lease state 34 35 submerged lands; and 36 37 WHEREAS, at its meeting of June 28, 2019, under agenda item 38 D-7, the Board of Land and Natural Resources rescinded its prior 39 action of May 26, 2017, item D-3, and instead approved the issuance of a separate term, non-exclusive easement to run with 40 41 the land and inure to the benefit of the abutting real property 42 and to be coterminous with GL5998, to which the Office of 43 Conservation and Coastal Lands had no objection; now, therefore, 44
