## HOUSE CONCURRENT RESOLUTION

URGING THE HAWAII STATE COMMISSION ON THE STATUS OF WOMEN TO CONVENE AN INTER-GOVERNMENTAL FEMINIST ECONOMIC RECOVERY WORKING GROUP.

WHEREAS, the virus known as SARS-CoV-2 causes a disease 1 named coronavirus disease 2019 (COVID-19), which spread globally 2 3 and was declared a pandemic by the World Health Organization on 4 March 11, 2020; and 5 WHEREAS, upon reaching Hawaii, the COVID-19 outbreak 6 7 disrupted the local economy, leaving hundreds of thousands of residents unemployed, underemployed, or facing financial 8 9 hardship; and 10 WHEREAS, low-wage workers were disproportionately harmed by 11 12 Hawaii's economic downturn, which worsened their financial precarity and left thousands of working families unable to pay 13 14 for food, housing, electricity, and other necessities; and 15 WHEREAS, at the peak of Hawaii's economic downturn, the 16 State experienced levels of unemployment not seen since the 17 Great Depression, according to the United States Bureau of Labor 18 Statistics; and 19 20 21 WHEREAS, women have been disproportionately harmed by the economic crisis and potential cuts to government services 22 because they earn less than men for substantially similar work; 23 24 and 25 WHEREAS, women in Hawaii are also at greater risk of 26 contracting COVID-19 due to women representing nearly two-thirds 27 of frontline essential workers in the State; and 28

WHEREAS, women additionally account for more than fifty 1 2 percent of jobs lost since February 2020 and continue to perform the majority of household and care-giving activities that 3 prevent them from engaging in full-time paid work; and 4 5 WHEREAS, according to a survey by LeanIn.org, a nonprofit 6 organization dedicated to helping women achieve their goals, 7 eighty percent of mothers have taken on more household work 8 9 since the COVID-19 pandemic began; and 10 WHEREAS, a report by the United Nations Educational, 11 Scientific, and Cultural Organization noted that ninety-one 12 percent of the world's students were affected by school and 13 14 childcare closures caused by the pandemic; and 15 16 WHEREAS, the Hawaii State Commission on the Status of Women issued a report in April 2020 entitled "Building Bridges, Not 17 Walking On Backs: Feminist Economic Recovery Plan for 18 19 COVID-19", which called for transitioning to an economy that 20 better values the essential work that sustains communities in the State; and 21 22 23 WHEREAS, in June 2020, the Maui County Council adopted a resolution in support of a feminist economic recovery plan and 24 on July 8, 2020, the Hawaii County Council passed a resolution 25 26 urging the county administration to consider gender differences in its response to COVID-19; now, therefore, 27 28 29 BE IT RESOLVED by the House of Representatives of the Thirty-first Legislature of the State of Hawaii, Regular Session 30 31 of 2021, the Senate concurring, that the Hawaii State Commission on the Status of Women is urged to convene an Inter-Governmental 32 33 Feminist Economic Recovery Working Group; and 34 35 BE IT FURTHER RESOLVED that the working group is requested 36 to develop a framework for an economic recovery that addresses the social, economic, ecological, and health care gaps exposed 37 38 by the pandemic and that promotes gender equity; and
