#### HOUSE CONCURRENT RESOLUTION

REQUESTING THE ESTABLISHMENT OF A WORKING GROUP TO REVIEW AND REPORT ON THE PROCEDURES FOR AND DETERMINATIONS ON APPLICATIONS FOR GEOGRAPHIC EXCEPTIONS WITHIN THE DEPARTMENT OF EDUCATION.

WHEREAS, section 302A-1143, Hawaii Revised Statutes, 1 requires a person of school age to attend the school of the 2 service area, as determined by the Department of Education, in 3 which the person resides, unless any one of three exceptions 4 5 apply; and 6 WHEREAS, one exception to this requirement is a requested 7 geographic exception to attend a school in another service area, 8 which may be granted at the discretion of the Department of 9 Education; and 10 11 WHEREAS, section 8-13-4, Hawaii Administrative Rules, vests 12 13 authority to approve or disapprove a geographic exception in the principal of the receiving school, after communicating with the 14 home school principal; and 15 16 WHEREAS, Board of Education Policy 500-12, relating to 17 geographic exceptions to the mandatory school attendance law, 18 provides that the process established by the Department of 19 Education for the handling and approval of geographic exception 20 requests shall be "equitable, widely publicized and 'user 21 friendly' to parents and children"; and 22 23 WHEREAS, the number of students attending public schools in 24 Hawaii under geographic exceptions has increased significantly 25 in recent years, with slightly over twenty thousand students 26 receiving geographic exceptions during the 2018-2019 school 27 28 year, as compared to approximately eight thousand students in 29 2005; and

WHEREAS, many Hawaii families have expressed concerns 1 2 regarding the fairness and objectivity of the criteria employed 3 when processing geographic exception requests; and 4 WHEREAS, the unprecedented investment in distance learning 5 6 equipment and training due to the COVID-19 pandemic has created innovative opportunities for students to enroll in distance 7 8 learning courses across multiple schools; and 9 10 WHEREAS, gathering information and exploring potential reforms related to geographic exception procedures will promote 11 equity and accountability in serving the diverse educational 12 needs of Hawaii's public school students; now, therefore, 13 14 15 BE IT RESOLVED by the House of Representatives of the 16 Thirty-first Legislature of the State of Hawaii, Regular Session 17 of 2021, the Senate concurring, that a working group be established to review and report on the procedures for and 18 19 determinations on applications for geographic exceptions within the department of education; and 20 21 22 BE IT FURTHER RESOLVED that the working group review and 23 report include: 24 25 (1) An analysis of the historical use of geographic 26 exceptions that reaches back at least ten years from 27 the present school year; 28 29 (2) Disaggregated data categorized by home school and receiving school; student demographics, including 30 ethnicity, for geographic exceptions that were 31 32 approved and those that were disapproved; special 33 education services needed; status as an English Language Learner student; status as a student 34 35 recipient of free or reduced lunch; and the reasons provided for approval or disapproval; 36 37 38 (3) A compilation of: the date of application for a 39 geographic exception by a parent or substitute legal guardian with the date of receipt by a school, the 40 41 number of days prior to or after the March 1 deadline 42 that the application was received, the number of days
