## HOUSE RESOLUTION

REQUESTING THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND TOURISM TO COMPILE A SHORT LIST OF FORTUNE 500 COMPANIES THAT ARE SUITABLE TO RELOCATE TO HAWAII AND IDENTIFY MEANS AND INCENTIVES TO ENTICE THESE COMPANIES TO RELOCATE.

WHEREAS, business activity and a strong economy are vital 1 to the public's health, safety, and welfare; and 2 3 WHEREAS, the economy of the State is largely dependent on 4 5 the tourism industry; and 6 WHEREAS, the effects of the coronavirus disease 2019 7 (COVID-19) pandemic and resulting job losses in the tourism 8 sector of the economy have demonstrated the urgent need for 9 business diversification in the State; and 10 11 WHEREAS, the COVID-19 pandemic has shown that many jobs and 12 businesses can be done from virtually anywhere with an internet 13 connection; and 14 15 WHEREAS, business leaders must consider economic 16 development opportunities, business climate, tax friendliness, 17 and quality of life in determining the location for their 18 operations; and 19 20 WHEREAS, the State consistently ranks among the top states 21 in the country for clean air quality, happiness of its citizens, 22 life expectancy, good weather, and overall quality of life; and 23 24 WHEREAS, given the advances in technology and the way 25 26 business is conducted in the modern age, there are more reasons for a company to relocate to Hawaii than ever before; and 27 28 WHEREAS, the following states have used incentives to 29 entice companies to relocate: 30 31

1 (1)Florida offers discretionary grant funding so long as 2 fifty jobs are created in a three-year period and an investment of at least \$50,000,000 is made; 3 4 (2) 5 Indiana offers a credit against corporate income tax liability where the credit can be up to fifty percent 6 7 of a corporation's approved costs in relocating to Indiana; provided that \$50,000,000 in new investment 8 9 and seventy-five new employees are required; 10 (3) Kentucky provides income tax credits to both regional 11 and national headquarter firms that can offset up to 12 13 one hundred percent of corporate income tax liability; 14 (4) Louisiana provides a rebate of up to twenty-five 15 percent of facilities and relocation costs over five 16 17 years; 18 (5) 19 Mississippi offers incentives for national and regional relocation of headquarters between \$500 and 20 21 \$2,000 per new job for a period of up to five years; 22 (6) 23 South Carolina has a twenty percent credit against corporate income tax liability, based on the cost of 24 the portion of the facility dedicated to headquarters 25 operation or direct lease costs for the first five 26 27 years of operation; 28 29 (7) Tennessee provides a refundable tax credit for relocation expenses resulting from a move where the 30 credit can be used to offset franchise or excise tax 31 liability in the year earned; provided that if the tax 32 liability is less than the credit, the difference is 33 refunded in cash; 34 35 (8) West Virginia offers a credit of up to ten percent of 36 the company's qualified investment to offset corporate 37 income and business franchise tax liability for up to 38 thirteen years; and 39 40 (9) Wisconsin provides a refundable business tax credit 41 42 based upon a percentage of wages paid to eligible

headquarter employees and, in addition to 1 reimbursement of up to fifty percent of training 2 costs, the company can earn credits for up to three 3 percent of capital investment in personal property and 4 5 up to five percent of investment in real property; provided that a new investment of \$1,000,000 is 6 7 required; and 8 WHEREAS, the State should explore all possible incentives 9 to lure well-paying jobs and investment to Hawaii; now, 10 therefore, 11 12 BE IT RESOLVED by the House of Representatives of the 13 Thirty-first Legislature of the State of Hawaii, Regular Session 14 of 2021, that the Department of Business, Economic Development, 15 and Tourism is requested to compile a short list of Fortune 500 16 companies that could potentially relocated to the State; and 17 18 19 BE IT FURTHER RESOLVED that the Department is requested to 20 also identify the means and incentives that might be attractive to entice the companies on the list to relocate to the State; 21 22 and 23 24 BE IT FURTHER RESOLVED that the Department of Business, Economic Development, and Tourism is requested to submit a 25 report of its findings and recommendations, including any 26 proposed legislation, to the Legislature no later than twenty 27 days prior to the convening of the Regular Session of 2022; and 28 29 BE IT FURTHER RESOLVED that a certified copy of this 30 Concurrent Resolution be transmitted to the Director of 31 Business, Economic Development, and Tourism. 32 33
