A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that with nearly thirty 2 thousand people registered as medical cannabis patients in 3 Hawaii, there is an unmet need for expertise in the field of 4 cannabinoid medicine to facilitate the exchange of educational 5 and research information related to the state authorized use of 6 cannabis for medical purposes in Hawaii. The legislature also 7 finds that the appropriate place to house such expertise should 8 be the University of Hawaii John A. Burns school of medicine. 9 The purpose of this Act is to create a cannabinoid medicine 10 program within the University of Hawaii to be administered by 11 the John A. Burns school of medicine.
- SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
 amended by adding a new section to part IV, subpart M, to be
 appropriately designated and to read as follows:
- 15 "§304A- Certified cannabinoid medicine program;
- 16 cannabinoid medicine expert. (a) There is established within
- 17 the University of Hawaii the cannabinoid medicine program, which
