A BILL FOR AN ACT

RELATING TO HEMP.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 14, Session Laws of Hawaii 2020 (Act 14) 2 established a registry for hemp processors within the department 3 of health, created a hemp processor special fund within the 4 department of health, and authorized the department of health to 5 collect fees and fines for the program. Act 14 also tasked the 6 department of agriculture with monitoring the transportation of 7 hemp within the State and enforced certain state restrictions 8 regarding the growth of hemp within the State. The Act did not 9 establish a special fund within the department of agriculture to 10 perform these duties. Allowing for the industrial hemp special 11 fund to be used for these purposes will allow the department of 12 agriculture to use the existing special fund to perform the new 13 regulatory duties relating to hemp.

14 The purpose of this Act is to allow for the industrial hemp 15 special fund to be utilized for the department of agriculture's 16 responsibilities regarding hemp created by Act 14, Session Laws 17 of Hawaii 2020.

5 necessary for fiscal year 2021-2022 to be used for the purposes

9 SECTION 4. Statutory material to be repealed is bracketed10 and stricken. New statutory material is underscored.

SECTION 5. This Act, upon its approval, shall take effect on July 1, 2021.
