There are appropriated or authorized from the sources of funding indicated below to collective bargaining statewide (BUF 102) the following sums or so much thereof as may be necessary to fund for fiscal biennium 2021-2023 all collective bargaining cost items in the agreement negotiated with the exclusive representative of collective bargaining unit (5):

2	SECTION 5. Salary increases and cost adjustments provided
3	in this Act for any officer or employee whose compensation is
4	paid, in whole or in part, from federal, special, or other funds
5	shall be paid wholly or proportionately, as the case may be,
6	from the respective funds.
7	SECTION 6. Funds appropriated or authorized by this Act
8	that are not expended or encumbered by June 30, 2022, and
9	June 30, 2023, of the respective fiscal years, shall lapse as of
10	those dates.
11	SECTION 7. This Act shall take effect on July 1, 2050.
