
A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS TO THE DEPARTMENT OF DEFENSE
RELATING TO COVID-19 EXPENDITURES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. This Act is recommended by the governor for
2 immediate passage in accordance with section 9 of article VII of
3 the Constitution of the State of Hawaii.

4 SECTION 2. The legislature finds that the impact of the
5 SARS-CoV-2 virus and resulting coronavirus disease 2019
6 (COVID-19) pandemic has been devastating to global, national,
7 and state economies. The Coronavirus Aid, Relief, and Economic
8 Security Act (CARES Act), Public Law 116-136, was enacted on
9 March 27, 2020, to address the extensive health and economic
10 fallout of the COVID-19 pandemic and provided federal funds to
11 support the State's COVID-19 relief efforts. With the
12 expiration of federal CARES Act funds, the legislature finds
13 that additional funds are needed to continue funding critical
14 COVID-19 response programs and activities for the remainder of
15 fiscal year 2020-2021.



1 Accordingly, the purpose of this Act is to appropriate
2 funds for the purpose of COVID-19 response activities and
3 provide transparency and accountability for the use of those
4 funds.

5 SECTION 3. There is appropriated out of the general
6 revenues of the State of Hawaii the sum of \$8,413,549 or so much
7 thereof as may be necessary for fiscal year 2020-2021 for the
8 transfer of contracts from the department of transportation to
9 the department of defense relating to the safe travels Hawaii
10 airport screening program.

11 The sum appropriated shall be expended by the department of
12 defense for the purposes of this Act.

13 SECTION 4. There is appropriated out of the general
14 revenues of the State of Hawaii the sum of \$600,000 or so much
15 thereof as may be necessary for fiscal year 2020-2021 for use of
16 the Hawaii tourism authority's Hawaii convention center to
17 operate a call center for the safe travels Hawaii airport
18 screening program.

19 The sum appropriated shall be expended by the department of
20 defense for the purposes of this Act.



1 SECTION 5. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$4,588,802 or so much
3 thereof as may be necessary for fiscal year 2020-2021 for the
4 procurement, storage, and distribution of personal protective
5 equipment to schools and other state agencies for statewide
6 operations as may be needed.

7 The sum appropriated shall be expended by the department of
8 defense for the purposes of this Act.

9 SECTION 6. The appropriations authorized by this Act shall
10 not lapse at the end of the fiscal year for which the
11 appropriations are made; provided that all moneys from the
12 appropriations that are unencumbered as of June 30, 2022, shall
13 lapse as of that date.

14 SECTION 7. This Act shall take effect on July 1, 2050.
