## A BILL FOR AN ACT

RELATING TO COUNTIES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that lands utilized by
- 2 the department of Hawaiian home lands to provide housing for
- 3 native Hawaiians are offered at affordable rates when compared
- 4 to similar housing available in Hawaii.
- 5 The purpose of this Act is to require counties to provide
- 6 for the maintenance of infrastructure for any housing
- 7 development for the department of Hawaiian home lands within a
- 8 specified time and under certain conditions.
- 9 SECTION 2. Chapter 46, Hawaii Revised Statutes, is amended
- 10 by adding to a new section to part I to be appropriately
- 11 designated and to read as follows:
- 12 "§46- Infrastructure maintenance; housing development
- 13 for the department of Hawaiian home lands. (a) Notwithstanding
- 14 any other provision to the contrary, infrastructure for any
- 15 housing development for the department of Hawaiian home lands
- 16 shall be maintained by the county in which the housing
- 17 development is located commencing sixty days after the receipt



1	by the ap	propriate county council of a completed application for
2	maintenan	ce request; provided that:
3	(1)	Applicable meter and connection fees and utility costs
4		relating to the infrastructure have been paid;
5	(2)	The infrastructure conforms to applicable county
6		standards in effect at the time of construction;
7	(3)	The completion of the improvements of the
8		infrastructure is granted approval by the county,
9		along with concurrence by the state historic
10		preservation division for any permitted action
11		requiring historic preservation review; and
12	(4)	The sixty day timeline may be tolled for the time
13		necessary to implement actions to mitigate impacts to
14		historic properties from the infrastructure
15		maintenance action.
16	(b)	For the purposes of this section, "infrastructure"
17	includes	waterlines and appurtenances; storm drainage, including
18	catch bas	in; sewer lines and appurtenances; waste disposal and
19	waste tre	atment systems; roadway improvements, including
20	pavement;	gutters; curbing; sidewalks; street trees; and street
21	lighting	that connect to county infrastructure."

- 1 SECTION 3. New statutory material is underscored.
- 2 SECTION 4. This Act shall take effect upon its approval.

## Report Title:

Counties; Department of Hawaiian Home Lands; Infrastructure

## Description:

Gives counties jurisdiction over the infrastructure of the Department of Hawaiian Home Lands housing developments in their boundaries under specific conditions. Requires counties, under specific conditions, to commence maintenance on that certain infrastructure within sixty days, subject to tolling to comply with certain other laws. (SD1)
