### A BILL FOR AN ACT

RELATING TO THE OFFICE OF MEDICAL CANNABIS CONTROL AND REGULATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 159, Session Laws of Hawaii (SLH) 2018, established the office of medical cannabis control and 2 3 regulation (OMCCR) under the health resources administration of 4 the department of health to administer medical cannabis 5 dispensary licensure and regulation pursuant to chapter 329D, 6 and the registration of qualifying patients and primary 7 caregivers pursuant to chapter 329, part IX, Hawaii Revised 8 Statutes.

9 The purpose of this Act is to allow the department of 10 health to fully operationalize the office of medical cannabis 11 control and regulation to ensure patient access and regulatory 12 oversight of the licensed dispensaries by:

(1) Changing the means of financing for general-funded
OMCCR positions from general funds to the medical
cannabis registry and regulation special fund;
(2) Establishing, hiring, and filling three new permanent
full-time equivalent positions (3.0 FTE) funded by the

3 (3) Authorizing a \$10.00 per year increase to the patient
4 registration fee beginning in FY 2022.

5 SECTION 2. Section 329-123, Hawaii Revised Statutes, is 6 amended by amending subsection (b) to read as follows:

7 "(b) Qualifying patients shall register with the 8 department of health. The registration shall be effective until 9 the expiration of the certificate issued by the department of 10 health and signed by the physician or advanced practice 11 registered nurse. Every gualifying patient shall provide 12 sufficient identifying information to establish the personal 13 identities of the qualifying patient and the primary caregiver. Qualifying patients shall report changes in 14 15 information within ten working days. Every qualifying patient 16 shall have only one primary caregiver at any given time. The 17 department of health shall issue to the qualifying patient a 18 registration certificate, and shall charge [\$35] \$45 per year." 19 SECTION 3. Section 329-123.5, Hawaii Revised Statutes, is 20 amended by amending subsection (e) to read as follows: 21 "(e) Each qualifying out-of-state patient shall pay a fee 22 of [\$45] \$55 for each registration and renewal."
