A BILL FOR AN ACT

RELATING TO SERVICES FOR KUPUNA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. In 2012, the legislature established in statute
- 2 the kupuna care program within the executive office on aging to
- 3 provide long-term services and supports to address the needs of
- 4 Hawaii's kupuna to age in their own homes. The program is
- 5 implemented through the area agencies on aging in each county.
- 6 The program offers two service options: traditional service
- 7 delivery through contracted providers or participant-directed
- 8 services and supports.
- 9 In 2017, the legislature established the kupuna caregivers
- 10 program in the executive office on aging to focus on working
- 11 caregivers and provide assistance to enable them to remain in
- 12 the workforce. The county area agencies on aging implement and
- 13 execute the kupuna caregivers program. For the kupuna
- 14 caregivers program, the qualified caregiver must work at least
- 15 30 hours per week and is awarded \$70 per day paid to the
- 16 contracted provider with the area agency on aging and providing
- 17 care to the care recipient. If additional services are needed

- 1 for the care recipient, kupuna care services are also provided.
- 2 In 2019, the legislature modified the amount provided to
- 3 caregivers to \$210 per week to allow provider agencies more
- 4 flexibility to increase the number of caregivers receiving
- 5 services. Due to the coronavirus disease 2019 pandemic in 2020,
- 6 many caregivers lost their jobs and contracted service providers
- 7 either closed or decreased their services. This increased the
- 8 burden on caregivers and their caregiving duties. With the
- 9 uncertainty of the State's economic situation and when
- 10 businesses will be able to recover, caregivers and service have
- 11 been forced to develop a "new normal". To give more flexibility
- 12 to the kupuna caregivers program, the executive office on aging
- 13 recommends that the area agencies on aging be allowed to have
- 14 more options to better serve kupuna and their caregivers.
- The purpose of this Act is to amend chapter 349, part II,
- 16 Hawaii Revised Statutes, entitled kupuna care and caregiver
- 17 support services, to allow for qualified caregivers to work less
- 18 than thirty hours per week during a declared state of emergency,
- 19 add the definition of a "financial management service provider",
- 20 and add traditional services and kupuna caregiver-directed
- 21 services to the kupuna care program.

1	SECTION 2. Section 349-16, Hawaii Revised Statutes, is		
2	amended to read as follows:

- 3 desired outcomes and lays out practical steps toward the

- 5 friends may provide assistance in developing a care recipient's
- 6 plan if the care recipient chooses to include them.] and allows
- 7 the caregiver to remain in the workforce.
- 8 "Qualified caregiver" means an individual who meets the
- 9 following requirements:
- 10 (1) Provides care for a care recipient; and
- 11 (2) Is employed at least thirty hours per week by one or
- more employers [-], or has reduced hours during a
- declared state of emergency.
- "Respite care" means services that offer temporary,
- 15 substitute supports, or living arrangements for care recipients
- 16 to provide a brief period of rest to qualified caregivers.
- 17 "Respite care" includes:
- 18 (1) In-home respite (personal care, homemaker [services],
- and other in-home respite);
- 20 (2) Respite provided by attendance of the care recipient

1	(3) Institutional respite provided by placing the care		
2	recipient in an institutional setting such as a		
3	nursing home for a short period of time as a respite		
4	service to the caregiver; and		
5	(4) Any combination of services to assist the caregiver a		
6	deemed appropriate by the area agency on aging."		
7	SECTION 3. Section 349-18 Hawaii Revised Statutes, is		
8	amended to read as follows:		
9	"[{]§349-18[}] Kupuna caregivers program. (a) The		
10	executive office on aging may establish the kupuna caregivers		
11	program. The program shall provide assistance to a qualified		
12	caregiver who meets the requirements of this section.		
13	(b) The program shall be coordinated and administered by		
14	the executive office on aging and implemented through the area		
15	agency on aging. The executive office on aging shall develop		
16	and implement a plan to maximize the number of caregivers serve		
17	by the program.		
18	(c) The kupuna caregivers program shall be delivered		
19	through two distinct service options: traditional service		
20	delivery or kupuna caregiver-directed services (kupuna		
21	caregiver-directed services), based on an support plan for each		

1	eligible (care recipient and the care recipient's qualified
2	caregiver	; provided that:
3	(1)	Traditional service delivery shall be through a
4		service provider organization or person who provides
5		services to clients under a formal contractual
6		arrangement with the executive office on aging or area
7		agency on aging who shall deliver to each care
8		recipient one or more services identified in section
9		349-18(d) to address the care recipient's specific
10		needs that have been identified in the care
11		recipient's and caregiver's support plan; and
12	(2)	Kupuna caregiver-directed services shall address the
13		care recipient's assessed needs and allow for the
14		qualified caregiver to remain in the workforce. The
15		care recipient and qualified caregiver shall have
16		shared decision-making authority over the budgeted
17		dollar amount to purchase and manage the needed
18		services and supports. Kupuna caregiver-directed
19		services shall provide the care recipient and
20		caregiver with a coach to assist the care recipient
21		with enrollment into the kupuna caregiver-directed
