A BILL FOR AN ACT

RELATING TO MARRIAGE LICENSE FEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 321, part XXXIV, Hawaii Revised 2 Statutes, mandates the department of health to establish the
- 3 statewide birth defects program to collect surveillance
- 4 information on birth defects; report the incidence, trends, and
- 5 causes of birth defects; and report information for the
- 6 development of prevention strategies to reduce the incidence of
- 7 birth defects.
- 8 Approximately four and a half per cent of Hawaii births
- $oldsymbol{9}$ have a major structural or genetic birth defect. Birth defects
- 10 may result in serious illness, developmental delays, long-term
- 11 disability, or death, and may cause an increased need for
- 12 health, education, or social services.
- 13 The Hawaii birth defects program has been supported by a
- 14 fee of \$10 per marriage license since 2002. However, the
- 15 program's salary and fringe expenses have almost doubled between
- 16 2002 and 2019. Without additional funding, the program will not
- 17 have sufficient funding for operating expenses beginning fiscal
- 18 year 2020-2021. Increasing the revenue for the birth defects

- 1 special fund will ensure that the program fulfills its mandated
- 2 responsibilities.
- 3 Furthermore, the moneys in the vital statistics improvement
- 4 special fund are not sufficient for the modernization and
- 5 automation of the vital statistics system and to offset costs
- 6 for the daily operations of the system of vital
- 7 statistics. There is an increased demand for marriage
- 8 certificates to prove legal name changes in order to meet the
- 9 required REAL ID Act standards for state-issued driver's
- 10 licenses and identification cards. The vital statistics
- 11 registration system is over twenty years old and needs to be
- 12 replaced to support more efficient processing of requests.
- 13 Furthermore, the current compensation for non-civil service
- 14 marriage license agents, who are appointed by the department of
- 15 health, is \$9 per license. This amount has not changed since
- 16 1998. The current compensation is not sufficient to meet the
- 17 operating costs of marriage license agents.
- 18 The purpose of this Act is to increase the marriage license
- 19 fee to support the Hawaii birth defects program, fund
- 20 modernization of the vital statistics system, and more fairly
- 21 compensate marriage license agents.

Section 338-14.6, Hawaii Revised Statutes, is 2 amended by amending subsection (c) to read as follows: 3 "(c) The fund shall consist of fees remitted pursuant to 4 section 338-14.5[.] and section 572-5. All realizations of the 5 fund shall be subject to the conditions specified in subsection 6 (b)." 7 SECTION 3. Section 572-5, Hawaii Revised Statutes, is 8 amended by amending subsections (a) and (b) to read as follows: 9 "(a) The department of health shall appoint, and at its 10 pleasure remove, one or more suitable persons as agents 11 authorized to grant marriage licenses under this chapter in each 12 judicial circuit. The agents may issue licenses from any state 13 facility when deemed necessary by the director. Any agent 14 appointed under this subsection and receiving an application for 15 a marriage license shall collect from the applicant for the 16 license [\$60,] \$100, of which the agent, except those provided 17 for in subsection (b), shall retain [\$9] \$15 for the agent's 18 benefit and compensation and shall remit [\$51] \$85 to the 19 director of health. Upon the receipt of remittances under this 20 subsection, the director of health shall deposit: 21 (1) [\$32] \$35 for each license issued to the credit of the 22 general fund of the State;

Description:

Amends the marriage license statute to support the Hawaii Birth Defects Program, modernization of the vital statistics system, and operating costs of marriage license agents.

TITLE:

PURPOSE:

The purpose of this Act is to increase the

marriage license fee to support the Hawaii

Birth Defects Program, support the modernization of the vital statistics system, and support the operating costs of

marriage license agents.

MEANS:

Amend sections 338-14.6(c) and 572-5(a) and

(b), Hawaii Revised Statutes (HRS).

JUSTIFICATION:

The Hawaii birth defects program responsibilities are established by chapter 321, part XXXIV, and chapter 324, part V, HRS. Increasing the birth defects special funds will ensure that the program maintains its responsibilities as required by state law and will address the issue of insufficient birth defect funds to cover program operating expenses.

The program needs funds to monitor major structural and genetic birth defects that adversely affect health and development. It needs to collect and compile date to be used for developing baseline rates, monitoring trends, and performing cluster investigations. Continued funding of the program is crucial because birth defects data are used by both communities and state

program is crucial because birth defects data are used by both communities and state programs to determine if an environmental or infectious health risk may be present. Data may also be used by public health and community programs in developing policies, prevention strategies, and services.

Since 2002, the program has been supported by a \$10 per marriage license, which is

placed into the birth defects special fund. However, the program's salary and fringe expenses have increased by over 90% between 2002 and 2020. The program does not have sufficient funding for operating expenses beginning fiscal year 2021-2022.

The vital statistics improvement special fund is not sufficient for the modernization and automation of the vital statistics system and to offset costs and improve efficiency for the daily operations of the system of vital statistics. Adding revenue from increased marriage license fees will allow necessary upgrades.

The current compensation for non-civil service marriage license agents, who are appointed by the Department of health, is \$9 per license. This amount has not changed since 1998. The current compensation is not sufficient to meet the operating costs of a marriage license agent.

Impact on the public: The Hawaii birth defects program needs to continue as a reliable resource for information about birth defects in communities. This information is critical especially when there are concerns about environmental or other hazards in the community that cause health problems.

Improved efficiency for the daily operations of the system of vital statistics will help to improve services provided to the public.

Increasing the compensation for non-civil service marriage license agents will support their continuing to issue marriage licenses.

Impact on the department and other agencies:
The Hawaii birth defects program provides to various public agencies the birth defects information needed for planning and development of appropriate statewide strategies, services, and public education

to prevent birth defects. Birth defects data has been provided to public agencies regarding claims of increased birth defects due to suspected environmental hazards or other risk factors such as Zika Virus infection.

Improved efficiency for the daily operations of the system of vital statistics will help the timely provision of data to other public agencies, as allowed by law.

Increasing the compensation for non-civil service marriage license agents will support the Department of Health in carrying out its responsibility to issue marriage licenses.
