### S.B. NO. 1150 JAN 2 7 2021 A BILL FOR AN ACT

RELATING TO SKILLED NURSING FACILITY LICENSING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to authorize the 2 department of health to recognize nationally recognized accreditation or certification organizations to demonstrate a 3 4 skilled nursing facility's compliance with all licensing 5 inspections required by the State. The Joint Commission 6 accredits nursing care centers and other accreditation or 7 certification organizations may also be recognized. Allowing 8 the department of health to recognize these organizations will 9 allow the department to continue its regulatory oversight 10 responsibilities for licensing purposes, allow for the 11 accreditation or certification to demonstrate a facility's 12 compliance with all licensing requirements by the state, and 13 allow the department more efficiently use its limited resources 14 for other health care facility regulatory oversight activities. 15 SECTION 2. Chapter 321, Hawaii Revised Statutes, is 16 amended by adding a new part to be appropriately designated and to read as follows: 17

 nursing facilities shall be licensed by the department to ensure
 the health, safety, and welfare of the individuals placed

9 The rules may provide that accreditation by a (C) 10 nationally recognized accreditation or certification 11 organization demonstrates a skilled nursing facility's 12 compliance with all licensing inspections required by the State. 13 The rules may exempt a skilled nursing facility from a licensing 14 inspection on a continuing basis throughout the term of the 15 accreditation or certification under the following conditions: The skilled nursing facility provides a certified copy 16 (1)

3 (d) The rules shall provide that the department may
4 conduct inspections and investigations of exempt skilled nursing
5 facilities regarding complaints, adverse accreditation or
6 certification findings, or periodic validation surveys.

7 (e) Information contained in reports of survey and
8 official accreditation or certification letters made by the
9 accreditation or certification organization used in determining
10 compliance with licensing requirements shall be public
11 information.

12 (f) All other records maintained by the department shall13 be governed by chapter 92F."

SECTION 3. This Act, upon its approval, shall take effect on July 1, 2021.

DEPARTMENT: HEALTH

TITLE: A BILL FOR AN ACT RELATING TO SKILLED NURSING FACILITY LICENSING.

PURPOSE: Authorize the Department of Health to recognize nationally recognized accreditation or certification organizations to demonstrate a skilled nursing facility's compliance with all licensing inspections required by the State.

MEANS: Add new part to chapter 321, Hawaii Revised Statutes.

JUSTIFICATION: Organizations such as The Joint Commission conduct accreditation or certification on skilled nursing facilities. Accreditation or certification requirements are generally more detailed and clinically current than those of the State. Allowing the Department of Health to recognize these organizations in lieu of having the State conduct licensing inspection will provide the department more efficient use of limited resources for other regulatory activities.
