BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 353, Hawaii Revised Statutes, is
2	amended by adding to part VII a new section to be appropriately
3	designated and to read as follows:
4	"§353- Automated victim information and notification
5	system coordinator. There is established a coordinator that
6	will manage the operations of the automated victim information
7	and notification system to ensure the provision of
8	uninterrupted, prompt and accurate services to crime victims;
9	manage the contract with the system provider; coordinate
10	communications with state and national partner agencies;
11	coordinate outreach and training on system operations and
12	services to stakeholders; and staff the automated victim
13	information and notification system governance committee. The
14	permanent position shall be subject to chapter 76. The position
15	shall report to the administrator of the reentry coordination
16	office of the department of public safety."

1	SECTION 2. There is appropriated out of the automated
2	victim information and notification system special fund,
3	established by section 353-136, Hawaii Revised Statutes, the sum
4	of \$130,000 or so much thereof as may be necessary for fiscal
5	year 2021-2022 and the same sum for fiscal year 2022-2023 for
6	the hiring of a permanent 1.0 full-time equivalent (1.0 FTE)
7	automated victim information and notification system
8	coordinator.
9	The sum appropriated shall be expended by the department of
10	public safety for the purposes of this Act.
11	SECTION 3. New statutory material is underscored.
12	SECTION 4. This Act, upon its approval, shall take effect
13	on July 1, 2021.

PURPOSE:

To establish a permanent 1.0 FTE coordinator position to manage the automated victim information and notification system (SAVIN).

MEANS:

Add a new section to part VII of chapter

353, Hawaii Revised Statutes.

JUSTIFICATION:

A full-time, permanent employee who will be responsible for the management of the SAVIN system will ensure the efficiency and effectiveness of the automated system so that crime victims are afforded with prompt and accurate services 24/7. The SAVIN Coordinator will also manage the contract and oversee the SAVIN system provider, coordinate communications with State and national partner agencies, coordinate outreach and training on SAVIN operations and services to stakeholders, and staff the SAVIN Governance Committee, which altogether will serve to reinforce partnerships with stakeholders, resulting in a more efficient and enhanced SAVIN program.

Impact on the public: The establishment of the SAVIN Coordinator position will enhance services to crime victims, providing them and their families with needed information to ensure their safety and well-being.

Impact on the department and other agencies:
Improved SAVIN system efficiency and
increased collaboration with stakeholders,
including the SAVIN Governance Committee.
