TITLE:

A BILL FOR AN ACT RELATING TO THE ELECTRONIC PRESCRIPTION ACCOUNTABILITY SYSTEM.

PURPOSE:

To amend section 329-101, Hawaii Revised Statutes (HRS), to require: (1) that the dispensing of a pharmacist-prescribed opioid antagonist be reported to the State's Electronic Prescription Accountability System (EPAS); and (2) that dispensers of a controlled substance report "zero" dispensing if no prescriptions for designated controlled substances are filled, not less than once every seven days.

MEANS:

Amend section 329-101(b) and (d), HRS.

JUSTIFICATION:

Proposed amendments to section 329-101, HRS, will accomplish the following:

- (1) Require the department's Narcotics
 Enforcement Division to identify the
 opioid antagonists that need to be
 reported to the Electronic Prescription
 Accountability System when they are
 dispensed pursuant to a prescription
 issued by a pharmacist;
- (2) Require that information related to the dispensing of an opioid antagonist, identified by the Narcotics Enforcement Division, pursuant to a prescription issued by a pharmacist, be reported to the Electronic Prescription Accountability System before it is dispensed;
- (3) Require that information on the filling of prescriptions related to pharmacist-prescribed opioid antagonists be reported to the Electronic Prescription Accountability System in numerical

format, not less than once every seven days; and

(4) Require that dispensers of a controlled substance report "zero" dispensing, if no prescriptions for designated controlled substances are filled, not less than once every seven days.

Impact on the public: This bill is intended to: (1) increase efficiency in using the Electronic Prescription Accountability System (EPAS) for pharmacists when issuing a prescription for an opioid antagonist; and (2) potentially increase the number of pharmacist-prescribed opioid antagonist prescriptions, thereby increasing the availability of these lifesaving drugs in the community.

Impact on the department and other agencies: These proposed amendments would assist the department's Narcotics Enforcement Division in determining compliance with the reporting requirements in section 329-101(d), and provide useful data for the Department of Health in studying the efficacy of Act 255, Session Laws of Hawaii 2019, which allowed a pharmacist to independently prescribe opioid antagonists to the public.
