#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 103D-307, Hawaii Revised Statutes, is

#### Report Title:

Emergency; Procurement; Public Property; Repairs; Equipment Failures; and Government Services

#### Description:

Amends section 103D-307, Hawaii Revised Statutes, Emergency Procurements, to add equipment failures, repairs to public property to protect against further loss of, or damage to, public property, to prevent or minimize serious disruption in continued functioning of government services. Replaces Chief Procurement Officer approval with an accounting report to the Legislature within sixty days after the end of the fiscal year in which the procurement was made.

#### JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO PROCUREMENT.

- PURPOSE: To amend section 103D-307, Hawaii Revised Statutes, Emergency Procurements, to add equipment failures, repairs to public property to protect against further loss of, or damage to public property, to prevent or minimize serious disruption in continued functioning of government services and to replace Chief Procurement Officer approval with an accounting report to the Legislature within sixty days after the end of the fiscal year in which the procurement was made.
- MEANS: Amend section 103D-307, Hawaii Revised Statutes.
- JUSTIFICATION: Maintenance schedules to extend the useful life of a facility or equipment are a primary function of preventive maintenance. A procuring agency's practical response to budgetary limitations may result in deferred maintenance or, when appropriate, through an emergency procurement.

Impact on the public: This bill broadens allowable emergency procurements within the intent of the procurement code's competition requirements. It shifts the showing of transparency from requiring approval from the Chief Procurement Officer to a reporting by the head of the purchasing agency to the Legislature.

Impact on the department and other agencies: This bill will allow the head of the purchasing agency to decide when it is appropriate to conduct an emergency procurement.
