A BILL FOR AN ACT

RELATING TO EMERGENCY FOOD MANAGEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that during times of
- 2 economic crisis, natural disasters, or other emergencies the
- 3 number of Hawaii residents and families who experience food
- 4 insecurity increases dramatically. Recent natural disasters
- 5 like hurricanes, flooding, tsunami, and volcanic eruptions, as
- 6 well as health and economic crises, including the coronavirus
- 7 disease 2019 (COVID-19) pandemic and subsequent government
- 8 mandated shutdowns, have forced people out of their homes,
- 9 disrupted the economy, and upset supply chains.
- 10 The legislature finds that local charitable food
- 11 organizations, including food banks, soup kitchens, shelters,
- 12 and food rescue operations, are critical parts of the food
- 13 safety net during times of crisis. The fallout from natural
- 14 disasters and similar crises place insurmountable pressure on
- 15 these organizations, which are often called upon by local
- 16 authorities to respond to the increased demand on limited

- 1 budgets. At least sixteen other states provide some type of
- 2 government funding support for charitable food organizations.
- 3 The legislature also recognizes that during times of
- 4 crisis, local food producers, including farmers, ranchers,
- 5 fishers, and others, can be negatively impacted. Disruptions to
- 6 supply chains can result in food spoiling before reaching its
- 7 intended destination. Work interruptions, whether by government
- 8 orders, pandemics, or other disasters, can also adversely affect
- 9 food producers' ability to bring their products to market.
- 10 Charitable food operations can offer a dual solution by not
- 11 only ensuring families in need have access to enough food to
- 12 sustain their household, but also by operating as an economic
- 13 stimulus by purchasing food directly from local Hawaii food
- 14 businesses. The legislature finds that there is a need to
- 15 connect community feeding and local food production to emergency
- 16 funding solutions.
- 17 The purpose of this Act is to create the Hawaii emergency
- 18 food assistance program and, upon an emergency proclamation from
- 19 the governor, require that moneys be appropriated to the program
- 20 to fund state food banks to purchase, store, and transport food
- 21 grown or produced in Hawaii to local communities for

- 1 distribution. This program will serve the State's food needs
- 2 during an emergency, provide local food producers with a market
- 3 to support those needs, and keep moneys within the State to
- 4 boost the local economy.
- 5 SECTION 2. Chapter 127A, Hawaii Revised Statutes, is
- 6 amended by adding two new sections to be appropriately
- 7 designated and to read as follows:
- 8 "<u>\$127A-A</u> Hawaii emergency food assistance program. (a)
- 9 There is established the Hawaii emergency food assistance
- 10 program to be administered by the department of agriculture
- 11 during a declared state of emergency to relieve food shortages
- 12 experienced by residents of the State, including low-income and
- 13 unemployed families and individuals, by distributing food grown
- 14 or produced in Hawaii to those persons.
- 15 (b) The department of agriculture shall make moneys
- 16 available to food banks located in the State pursuant to
- 17 subsection (a) using moneys in the Hawaii emergency food
- 18 assistance program special fund established pursuant to section
- **19** 127A-B.
- 20 (c) Food banks that receive moneys pursuant to this
- 21 section shall use the moneys to purchase, store, and transport



1 food grown or produced in Hawaii to be distributed to recipients 2 at no cost to the recipients. 3 (d) For purposes of this section: 4 (1) "Food bank" has the same meaning as in title 7 U.S.C. 5 section 7501(5). 6 "Produced in Hawaii" has the same meaning as in (2) 7 section 486-119(b). 8 §127A-B Hawaii emergency food assistance program special 9 fund. (a) There is established in the state treasury the 10 Hawaii emergency food assistance program special fund into which shall be deposited the following: 11 12 Moneys appropriated to the fund pursuant to section (1) 13 127A-16; 14 (2) Appropriations by the legislature to the special fund; (3) 15 Gifts, donations, and grants from public agencies and 16 private persons; and 17 Interest accrued from moneys in the special fund. (4)Moneys in the special fund shall be used to provide 18 (b) immediate relief from food shortages during a declared state of 19

emergency pursuant to section 127A-A. Moneys shall not be

- 1 expended from the special fund unless a state of emergency has
- 2 been declared pursuant to section 127A-14.
- 3 (c) Moneys deposited into the special fund shall not lapse
- 4 to the credit of the general fund.
- 5 (d) Expenditures from the special fund shall be authorized
- 6 and administered by the department of agriculture.
- 7 (e) The special fund shall not be subject to sections
- **8** 36-27, 36-30, or 37-53."
- 9 SECTION 3. Section 36-27, Hawaii Revised Statutes, is
- 10 amended by amending subsection (a) to read as follows:
- "(a) Except as provided in this section, and
- 12 notwithstanding any other law to the contrary, from time to
- 13 time, the director of finance, for the purpose of defraying the
- 14 prorated estimate of central service expenses of government in
- 15 relation to all special funds, except the:
- 16 (1) Special out-of-school time instructional program fund
- 17 under section 302A-1310;
- 18 (2) School cafeteria special funds of the department of
- 19 education;
- 20 (3) Special funds of the University of Hawaii;
- 21 (4) State educational facilities improvement special fund;

- 2 administrative expenses incurred by the department responsible
- 3 for the operations supported by the special fund concerned."
- 4 SECTION 5. There is appropriated out of the general fund
- 5 of the State the sum of \$ or so much thereof as may be
- 6 necessary for fiscal year 2021-2022 and the same sum or so much
- 7 thereof as may be necessary for fiscal year 2022-2023 to be
- 8 deposited into the Hawaii emergency food assistance program
- 9 special fund.
- 10 SECTION 6. There is appropriated out of the Hawaii
- 11 emergency food assistance program special fund the sum of \$
- 12 or so much thereof as may be necessary for fiscal year 2021-2022
- 13 and the same sum or so much thereof as may be necessary for
- 14 fiscal year 2022-2023 for expenditure pursuant to section 2 of
- 15 this Act.
- 16 The sums appropriated shall be expended by the department
- 17 of agriculture for the purposes of this Act.
- 18 SECTION 7. In codifying the new sections added by section
- 19 2 of this Act, the revisor of statutes shall substitute
- 20 appropriate section numbers for the letters used in designating
- 21 the new sections in this Act.

- 1 SECTION 8. Statutory material to be repealed is bracketed
- 2 and stricken. New statutory material is underscored.
- 3 SECTION 9. This Act shall take effect on July 1, 2050.
