A BILL FOR AN ACT

RELATING TO EARLY LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the demand for 2 quality early care and education far exceeds the amount of 3 available and qualified early childhood educators. Given the 4 critical need to expand access to and the availability of 5 high-quality early care and education programs for the benefit 6 of the State's children and their families. The legislature 7 recognizes that there must also be enough qualified educators to staff the programs. This will ultimately benefit the entire 8 9 society, particularly now as the State focuses on taking steps 10 toward economic recovery from the unprecedented strain of COVID-19. 11

12 The legislature further recognizes that these educators 13 must have the research-based knowledge and competencies to work 14 with young children and their families. Researchers have 15 repeatedly demonstrated that children, particularly those who 16 come from disadvantaged backgrounds, will benefit from early

childhood education; however, it is emphasized that the
education must be of high quality.

3 The legislature also finds that preschool teachers are amongst the lowest paid occupations, on average making less than 4 5 many non-skills positions such as parking lot attendants. 6 Moreover, it is difficult to attract individuals to this highly 7 specialized field with such low pay and to overcome the 8 misperception that preschool teachers are babysitters. There 9 are many professionals currently working in the early childhood 10 field who aspire to work in higher paying positions and could 11 benefit from obtaining the necessary credentials. A stipend 12 program will assist with workforce development and support those 13 individuals seeking to become high-quality early childhood 14 educators, thereby moving the State toward reaching its goal of increasing access to high-quality early learning programs. 15

Acknowledging the importance of obtaining credentials or coursework in early childhood education, a stipend program aligns with national policy initiatives, which recognize that workforce development is key to creating the kind of early childhood systems that make a significant and impactful difference for families and children by financing and bolstering

1 programs that help offset the cost of tuition and encourage 2 higher educational attainment. Furthermore, the federal 3 government recognized the necessity to develop the workforce of 4 early childhood professionals and allowed for preschool 5 development grant funds to be utilized for stipend and 6 scholarship programs. There currently exists private sector 7 funding for the establishment of a stipend program. Without 8 qualified teaching staff, providers across the system will be 9 unable to expand the inventory of early care and education 10 opportunities. Where providers do develop programs, they run 11 the risk of implementing programs that may be detrimental to 12 children, many of whom are living in poverty and who have 13 experienced trauma, as well as possibly excluding children 14 through suspension and expulsion practices.

15 The purpose of this Act is to make stipends available 16 through an early childhood educator stipend program, to be 17 administered by the executive office on early learning, to 18 encourage individuals, especially those already working in the 19 early childhood field, to pursue a certificate, degree, or 20 license in early childhood education and fill the critical need 21 for qualified educators across the early learning system in
