A BILL FOR AN ACT

RELATING TO DETACHED DWELLINGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 46, Hawaii Revised Statutes, is amended		
2	by adding a new section to be appropriately designated and to		
3	read as follows:		
4	"§46- Detached dwellings; authorization required. (a)		
5	Each county shall adopt ordinances authorizing the construction		
6	and occupation of detached dwelling units upon application in		
7	areas zoned as residential.		
8	(b) Notwithstanding any other law to the contrary, a		
9	county shall not deny approval for a detached dwelling unit if:		
10	(1) The property contains one single-family dwelling		
11	occupied by the property owner, or family of the		
12	property owner, unless the property owner will occupy		
13	the detached dwelling unit after its completion;		
14	(2) The floor area ratio of the property does not exceed		
15	0.7, including the detached dwelling unit;		
16	(3) The number of bathrooms in the detached dwelling unit		
17	does not exceed:

1		(A) Two on a zoning lot size up to 6,999 square feet;
2		(B) Three on a zoning lot size between 7,000 and
3		9,999 square feet; or
4		(C) Four on a zoning lot size of 10,000 square feet
5		or greater;
6	(4)	The detached dwelling unit is furnished with a kitchen
7		sink, cooking appliance, and refrigeration facilities,
8		each having a clear working space of no less than
9		thirty inches in front;
10	(5)	The impervious surface area of the zoning lot does not
11		exceed seventy-five per cent of the total zoning lot
12		area, including the detached dwelling unit;
13	<u>(6)</u>	The number of wet bars in the detached dwelling unit
14		does not exceed one; and
15	(7)	The detached dwelling unit has a floor area of:
16		(A) At least two hundred twenty square feet;
17		(B) No more than eight hundred fifty square feet if
18		the unit contains one bedroom; or
19		(C) No more than one thousand square feet if the unit
20		contains more than one bedroom;
