A BILL FOR AN ACT

RELATING TO HIGHWAY PATROL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that law enforcement
- 2 service and assistance along state highways is inadequate.
- 3 Further, local police and state sheriff deputies do not have
- 4 sufficient time and resources to provide these services.
- 5 Accordingly, the purpose of this Act is to establish a
- 6 state highway patrol within the sheriff division of the
- 7 department of public safety.
- 8 SECTION 2. Chapter 353C, Hawaii Revised Statutes, is
- 9 amended by adding a new section to be appropriately designated
- 10 and to read as follows:
- 11 "§353C- Highway patrol. (a) There is established
- 12 within the sheriff division of the department a state highway
- 13 patrol that shall consist of law enforcement officers appointed
- 14 by the sheriff, who shall fix their compensation.
- (b) The state highway patrol shall actively patrol for
- 16 violations of title 17 and all other state and county laws,

- 1 ordinances, and rules regulating traffic all highways and
- 2 facilities owned or leased by the State.
- 3 (c) State highway patrol officers shall have and may
- 4 exercise all of the powers and authority and the benefits and
- 5 privileges of a deputy sheriff, including the power to arrest;
- 6 provided that these powers shall remain in force and effect only
- 7 while in actual performance of their duties; provided further
- 8 that these powers and authority shall not extend to any
- 9 properties or roads that are not owned or leased by the State."
- 10 SECTION 3. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so much
- 12 thereof as may be necessary for fiscal year 2021-2022 and the
- 13 same sum or so much thereof as may be necessary for fiscal year
- 14 2022-2023 for the establishment of a state highway patrol within
- 15 the sheriff division of the department of public safety,
- 16 including but not limited to the following:
- 17 (1) The acquisition of any necessary equipment, firearms,
- uniforms, and vehicles;
- 19 (2) The acquisition, leasing, or construction of any
- 20 necessary offices and facilities, including any

1	facilities necessary for the storage of state highway
2	patrol vehicles; and
3	(3) Salaries and benefits for both law enforcement and
4	non-law enforcement personnel.
5	The sums appropriated shall be expended by the sheriff
6	division of the department of public safety for the purposes of
7	this Act.
8	SECTION 4. New statutory material is underscored.
9	SECTION 5. This Act shall take effect on July 1, 2021.
