### A BILL FOR AN ACT

RELATING TO THE PLANT QUARANTINE BRANCH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that responding quickly
- 2 to newly detected invasive species can often prevent the species
- 3 from becoming firmly established, saving taxpayers money in the
- 4 long term. The United States Department of Agriculture has
- 5 stated that foreign pests and disease already cost the United
- 6 States' economy tens of billions of dollars annually in lower
- 7 crop values, eradication programs, emergency payments to
- ${f 8}$  farmers, and increased costs for food and other natural
- 9 resources.
- 10 Currently, with the spread of coffee leaf rust fungus,
- 11 State agencies lack the resources, such as quarantine
- 12 facilities, and response mechanisms to deal with these newly
- 13 identified threats and may be missing opportunities to eliminate
- 14 them. Because the introduction of coffee leaf rust fungus as an
- 15 alien invasive species poses serious problems to the State's
- 16 ecosystem, any introduction of alien invasive species via the
- 17 airport or any other entry points throughout the State may lead

- 1 to significant cumulative impacts. The lack of resources and
- 2 facilities can allow invasive species to become established in
- 3 the State, making mitigation efforts more protracted and
- 4 expensive.
- 5 The legislature further finds that the plant quarantine
- 6 branch of the department of agriculture is tasked with
- 7 preventing the introduction and spread of harmful pests and
- 8 diseases into the State by regulating domestic import,
- 9 performing border inspections, and facilitating post-border
- 10 detection and control of agricultural pests. The plant
- 11 quarantine branch is a critical component in meeting the treat
- 12 of invasive species entering Hawaii and spreading throughout
- 13 Hawaii through the State's ports of entry.
- Accordingly, the purpose of this Act is to appropriate
- 15 moneys out of the general revenues of the State of Hawai'i to
- 16 expand state-run quarantine facilities under the jurisdiction of
- 17 the department of agriculture's plant quarantine branch.
- 18 SECTION 2. There is appropriated out of the general
- 19 revenues of the State of Hawaii the sum of \$500,000 or so much
- 20 thereof as may be necessary for fiscal year 2021-2022 and the
- 21 same sum or so much thereof as may be necessary for fiscal year

- 1 2022-2023 for the expansion of state-run quarantine facilities
- 2 under the jurisdiction of the department of agriculture's plant
- 3 quarantine branch.
- 4 The sums appropriated shall be expended by the department
- 5 of agriculture for the purposes of this Act.
- 6 SECTION 3. The department of agriculture shall submit a
- 7 report of its findings and recommendations relating to the
- 8 expenditure of funds towards the purpose of this Act, including
- 9 any proposed legislation, to the legislature no later than
- 10 twenty days prior to the convening of the regular session of
- 11 2022.
- 12 SECTION 4. This Act shall take effect upon its approval.
