### A BILL FOR AN ACT

RELATING TO VOTING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended
- 2 by adding a new section to part II to be appropriately
- 3 designated and to read as follows:
- 4 "\$11- Automatic registration. (a) An application for
- 5 voter registration shall be a part of the application for
- $\mathbf{6}$  issuance of an identification card under section 286-303 and the
- 7 application for issuance of a driver's license under
- 8 section 286-111. Each application for voter registration shall
- 9 include a space to request a change of name or address.
- 10 (b) Applications for an identification card or driver's
- 11 license shall not be processed until the applicant completes the
- 12 portion of the application related to voter registration,
- 13 including change in name or address, indicates the applicant's
- 14 choice of whether to register to vote, or, if already registered
- 15 to vote, is offered the opportunity to decline to change the
- 16 applicant's voter registration information. The submission of
- 17 the application for the issuance of an identification card under



- 1 <u>section 286-303</u> and the application for a driver's license under
- 2 section 286-111 shall be deemed to authorize the examiner of
- 3 drivers to collect and transmit the information necessary to
- 4 register the applicant as a voter or make changes to the
- 5 applicant's voter registration information if the applicant made
- 6 such a choice. The examiner of drivers shall electronically
- 7 transmit the necessary information to the clerk of the county in
- 8 which the applicant resides, election officials, and the online
- 9 voter registration system pursuant to subsection (d).
- 10 The examiner of drivers shall not transmit any information
- 11 necessary to register an applicant as a voter nor change any
- 12 voter registration information if the applicant makes a choice
- 13 not to be registered to vote or make changes to the applicant's
- 14 voter registration information. The examiner of drivers shall
- 15 not transmit any information related to a voter application or
- 16 changes to the applicant's voter registration information if the
- 17 applicant presents a document demonstrating a lack of United
- 18 States citizenship.
- 19 (c) Upon receipt of the completed voter registration
- 20 application or changes to the applicant's voter registration
- 21 information transmitted from the examiner of drivers, the clerk

2 application in accordance with this part; provided that approved 3 voter registration applications received from the examiner of 4 drivers pursuant to this section shall be treated as having a 5 valid signature for purposes of section 11-15(c), whether 6 transmitted electronically or by facsimile transmission. The qualified 11 applicant may choose on the same form that a change be made to 12 the qualified applicant's name or address in the case of 13 existing voter registration information. 14 (b) The submission of the application for voter 15 registration together with the license or permit application 16 shall be deemed to authorize the examiner of drivers to collect and transmit the information necessary to register the qualified 17 18 applicant as a voter or make changes to the qualified 19 applicant's voter registration information if the applicant made 20 such a choice, and the examiner of drivers shall electronically 21 transmit the necessary information to the clerk of the county in

- 4 The examiner of drivers shall not transmit any information

- 21 for a new, renewal, or duplicate identification card shall



- 1 automatically be registered to vote with the clerk of the
- 2 appropriate county upon completion of an application for
- 3 identification card and the application for voter registration
- 4 as required by section 11- if the qualified applicant makes a
- 5 choice to be registered to vote. The qualified applicant may
- 6 request on the same form that a change be made to the qualified
- 7 applicant's name or address in the case of existing voter
- 8 registration information.
- **9** (b) The submission of the application for voter
- 10 registration together with the application for the
- 11 identification card shall be deemed to authorize the examiner of
- 12 drivers to collect and transmit the information necessary to
- 13 register the qualified applicant as a voter or make changes to
- 14 the qualified applicant's voter registration information if the
- 15 applicant made such a choice, and the examiner of drivers shall

- 9 SECTION 5. Section 286-111, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "\$286-111 Application for license, provisional license,
- 12 instruction permit, limited purpose driver's license, limited
- 13 purpose provisional driver's license, or limited purpose
- 14 instruction permit; fees. (a) Every application for an
- 15 instruction permit, provisional license, driver's license,
- 16 limited purpose driver's license, limited purpose provisional
- 17 driver's license, or limited purpose instruction permit shall be
- 18 made upon a form furnished by the examiner of drivers and shall
- 19 be verified by the applicant before a person authorized to
- 20 administer oaths. The examiner of drivers and officers serving
- 21 under the examiner may administer the oaths without charge.

- 1 Each application for an instruction permit for a category (1),
- 2 (2), (3), or (4) license shall be accompanied by a fee to be
- 3 determined by the council of each county, and each application
- 4 for a provisional license or driver's license shall be
- 5 accompanied by the fee, unless the applicant has already paid

- 1 (c) The director of transportation shall establish a fee
- 2 schedule for all commercial driver's licensing examinations.
- 3 The fees collected for a commercial driver's license shall
- 4 become state realizations and shall be deposited in the state
- 5 highway fund. The State shall reimburse the counties all costs
- 6 for administering the commercial driver's licensing program.
- 7 The amount of reimbursement shall be determined by the director
- 8 of transportation.
- 9 (d) Every application shall state the full name, date of
- 10 birth, gender designation, occupation, veteran status if
- 11 applicable (including veterans of the Korean conflict and
- 12 persons who served in the armed forces of the Republic of Korea,
- 13 who fought under the command of the United Nations led by the
- 14 United States, during the Korean conflict and are currently
- 15 United States citizens) and desired by the applicant, social
- 16 security number if the applicant is eligible for a social
- 17 security number, the residence address, and business address, if
- 18 any, of the applicant, shall briefly describe the applicant, and
- 19 shall state whether the applicant has theretofore been licensed
- 20 as a driver, and, if so, when and in what state or country, and
- 21 whether any such license has ever been suspended or revoked, or

- 1 whether an application has ever been refused, and if so, the
- 2 date of and reason for the suspension, revocation, or refusal.
- 3 The examiner of drivers shall not require documentation for
- 4 an applicant's selection of gender designation or an applicant's
- 5 request for an amendment to a gender designation other than the
- 6 applicant's self-certification of their chosen gender
- 7 designation; provided that the examiner of drivers shall not be
- 8 prohibited from requiring documentation that may incidentally
- 9 show an applicant's birth sex category if [such] the
- 10 documentation is necessary to establish that the applicant is
- 11 legally entitled to a license.
- For [+]purposes[+] of this subsection, "gender designation"
- 13 shall have the same meaning as in section 286-109(a).
- 14 (e) Except as provided in section 286-104.5, if the
- 15 applicant is not eligible to receive a social security number,
- 16 the applicant shall submit, in lieu of providing proof of social
- 17 security number pursuant to subsection (d):
- 18 (1) A United States Social Security Administration letter
- 19 stating that the applicant is ineligible to obtain a

8	SECTION 6. Section 286-303, Hawaii Revised Statutes, is

- 10 applicant is legally entitled to an identification card.
- 11 For purposes of this subsection, "gender designation" shall
- 12 have the same meaning as in section 286-109(a).
- 13 (d) The application also shall state whether the applicant
- 14 has an advance health-care directive. If the applicant has an
- 15 advance health-care directive, the identification card shall
- 16 bear the designation "AHCD".
- (e) [The examiner of drivers, in accordance with
- 18 section 11-15, at the time of application, shall make available
- 19 an application for voter registration to every applicant for an
- 20 identification card who is eligible to register to vote.] An
- 21 application for an identification card from the examiner of

- 1 drivers shall include the voter registration application

- 3 (f) The examiner of drivers shall maintain a suitable,

- 9 SECTION 7. Section 286-311, Hawaii Revised Statutes, is
- 10 amended by amending subsection (a) to read as follows:
- "(a) All information and records acquired by the examiner
- 12 of drivers under this part shall be confidential [-]; provided
- 13 that the examiner may transmit voter registration information as
- 14 required under sections 11- , 286-A, 286-B, 286-111,
- 15 and 286-303. All information and records shall be maintained in
- 16 an appropriate form and in an appropriate office in the custody
- 17 and under the control of the examiner. The information shall be
- 18 available only to authorized individuals under [such]
- 19 restrictions as the director shall prescribe. The examiner may
- 20 dispose of any application or identification card, or
- 21 information or record relating to the application or

- 1 identification card, [which] that does not include a social
- 2 security number, without regard to chapter 94, whenever, in the
- 3 examiner's discretion, retention of the information or record is
- 4 no longer required or practicable."
- 5 SECTION 8. The examiner of drivers in each county shall
- 6 cooperate with the office of elections to develop the forms and
- 7 applications necessary to effectuate the purposes of this Act.
- 8 SECTION 9. In codifying the new sections added by
- 9 sections 2 and 3 and referenced in section 7 of this Act, the
- 10 revisor of statutes shall substitute appropriate section numbers
- 11 for the letters used in designating the new sections in this
- 12 Act.
- 13 SECTION 10. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 11. This Act shall take effect on July 1, 3021.
