## A BILL FOR AN ACT

RELATING TO VISION ZERO.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that vision zero is a
- 2 traffic safety program that seeks to end traffic deaths and
- 3 serious injuries.
- 4 The legislature further finds that the idea originated in
- 5 Sweden, which adopted vision zero as a national policy in 1997
- 6 and by 2013 had achieved a record low of road accident
- 7 fatalities. In 2000, the state of Washington became the first
- 8 in the United States to adopt the program and to set an
- 9 aggressive goal of zero traffic deaths and serious injuries by
- 10 2030. Washington reported that the state averaged twenty-two
- 11 fewer traffic fatalities and eighty fewer serious injuries each
- 12 year from 2002 to 2011.
- 13 The legislature finds that many of the country's large
- 14 cities, including Boston, Chicago, Los Angeles, New York, and
- 15 Washington, D.C., and certain states, including Maryland, North
- 16 Carolina, and North Dakota, have adopted vision zero or similar
- 17 programs. The Federal Highway Administration is also committed



- 1 to eliminating traffic fatalities and serious injuries, adopting
- 2 a policy called "toward zero deaths."
- 3 The purpose of this Act is to require the department of
- 4 transportation to implement a vision zero program.
- 5 SECTION 2. Section 286-7.5, Hawaii Revised Statutes, is
- 6 amended to read as follows:
- 7 "[{] §286-7.5[{}] Vision Zero. (a) The department of
- 8 transportation and the county transportation departments shall
- 9 [adopt] implement a Vision Zero [policy.] program by July 1,
- **10** 2022.
- 11 (b) The goal of the Vision Zero program shall be to
- 12 eliminate all traffic fatalities and serious injuries in Hawaii
- 13 by 2045 through a combination of engineering, enforcement,
- 14 education, and emergency response strategies that focus on
- 15 equity.
- 16 (c) The department of transportation, in conjunction with
- 17 the counties, shall take the necessary steps to implement the
- 18 program.
- 19 (d) The director of transportation may adopt rules
- 20 pursuant to chapter 91 for the purposes of this section.

- 1 (e) No later than twenty days prior to the convening of
- 2 <u>each regular session</u>, the department of transportation shall
- 3 submit a report to the legislature, including any proposed
- 4 legislation, on the progress made toward the goal of eliminating
- 5 traffic fatalities and serious injuries."
- 6 SECTION 3. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 4. This Act shall take effect upon its approval.
