A BILL FOR AN ACT

RELATING TO CARBON OFFSETS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that climate change is 2 the most pressing issue of our time. There are many contributors to climate change, and transportation-generated 3 greenhouse gas emissions are a significant contributor. 4 The 5 legislature acknowledges that, within the transportation sector, 6 the air transportation component faces particularly difficult technical challenges in reducing carbon dioxide emissions 7 associated with air travel. Since air travel is essential to 8 9 tourism, the legislature finds that air travel and its 10 associated carbon emissions will remain key elements of Hawai'i's 11 intertwined economy and climate for the foreseeable future.

12 In the past few years, the United Nations has established 13 an extensive framework for the provision of carbon offsets for 14 carbon emissions resulting from international air travel, known 15 as carbon offsetting and reduction scheme for international 16 aviation (CORSIA). A pilot phase for this program is scheduled

for 2021. CORSIA, however, will not apply to air travel to
Hawai'i from the continental United States.

The legislature further finds that, for essential activities such as air travel that are intractably resistant, at least in the near term, to technological solutions to carbon emission reductions, the use of carbon offsets to compensate for those emissions is a strategic necessity for achieving the zero emission clean economy target set for the State by Act 15, Session Laws of Hawaii 2018.

10 The purpose of this Act is to provide a process by which 11 the department of transportation shall assist persons traveling 12 by air to or from airports in Hawai'i in the purchase of 13 verifiable carbon offsets to compensate for carbon dioxide 14 emissions from air travel. While this Act relies on the 15 voluntary purchase of carbon offsets by air travelers from 16 providers of such offsets, the legislature anticipates that many 17 travelers will take advantage of the program, given the 18 increasing awareness by air travelers of the climate change 19 implications of their travel. The legislature additionally 20 finds that the ease of purchasing offsets may have the effect of 21 enhancing the desirability of travel to Hawai'i.

11		capability by which air travelers may arrange for the

1	(b) For the purposes of this section:			
2	"Carbon offset" means a reduction in carbon dioxide or			
3	other greenhouse gases in, or emitted into, the atmosphere that			
4	is achieved by or on behalf of a person to compensate, in a			
5	carbon dioxide-equivalent amount, for the emissions of carbon			
6	dioxide resulting from air travel by the person to or from an			
7	airport in the State. "Carbon offset" includes an action that			
8	removes greenhouse gases from the atmosphere or that reduces			
9	future greenhouse gas emissions.			
10	"Qualified air travel" means any air travel regulated under			
11	this chapter that occurs between an airport in the State and			
12	another airport in the State or an airport in the continental			
13	United States.			
14	"Verified" means, with respect to a carbon offset, a			
15	reduction in carbon dioxide, or carbon dioxide-equivalent amount			
16	of other greenhouse gases, that is determined to be real,			
17	permanent, and unlikely to occur in the absence of the offset			
18	program, through a process of validation and verification by an			
19	independent third party."			
20	SECTION 3. Section 261-4, Hawaii Revised Statutes, is			
21	amended by amending subsection (a) to read as follows:

1 "(a) Establishment, operation, maintenance. The 2 department of transportation may, on behalf of and in the name 3 of the State, out of appropriations and other moneys available 4 or made available for such purposes, plan, acquire, establish, 5 construct, enlarge, improve, maintain, equip, install, operate, 6 regulate, and protect, airports, air navigation facilities, 7 buildings, and other facilities to provide for the servicing of 8 aircraft; to provide for the comfort, accommodation, and 9 convenience of air travelers [+], which may include but is not 10 limited to the provision of assistance to air travelers who wish 11 to purchase carbon offsets for carbon dioxide emissions 12 resulting from their air travel to or from an airport in the 13 State; and to protect against airport hazards." 14 SECTION 4. Statutory material to be repealed is bracketed 15 and stricken. New statutory material is underscored. 16 SECTION 5. This Act shall take effect upon its approval. 17
