A BILL FOR AN ACT

RELATING TO THE ENVIRONMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. (a) The department of health shall:
2	(1)	Fill the vacant environmental management division
3		chief staff position by October 1, 2021;
4	(2)	Require that the clean water branch of the
5		environmental division continue to test water quality
6		as part of its Hawaii beach monitoring program during
7		brown water advisories, adhering to their regularly
8		scheduled beach sampling schedule; provided that no
9		water sample shall be collected by clean water branch
10		personnel until any hazardous conditions at affected
11		beaches have subsided;
12	(3)	Issue health advisories during brown water advisories
13		that explain the health risks associated with water
14		runoff, including but not limited to informational
15		signs posted during these advisories at affected
16		tier 1 beaches;

1	(4)	Take into consideration environmental justice issues
2		in the assessment of use, when considering usage and
3		public health risk for its determination and ranking
4		of beaches for inclusion in Hawaii's beach monitoring
5		program; and

- (5) Establish an environmental management division oversight advisory board to provide oversight and quidance to the environmental management division.
- 9 (b) The department of health shall adopt or amend its
 10 administrative rules in accordance with chapter 91, Hawaii
 11 Revised Statutes, as necessary to implement this section.
- 12 (c) As used in this Act, "tier 1 beaches" means those
 13 beaches designated as tier 1 by the department of health
 14 pursuant to the federal Beaches Environmental Assessment and
 15 Coastal Health Act of 2000.
- SECTION 2. (a) The legislative reference bureau shall conduct a comprehensive review of the environmental management division of the department of health; provided that the comprehensive review shall focus on, but not be limited to the environmental management division's clean water branch and wastewater branch.

DOH; Environmental Management Division; Clean Water Branch; Wastewater Branch; Hawaii Beach Monitoring Program; Environmental Justice; Brown Water Advisories; Beaches; Legislative Reference Bureau; Review

Description:

Requires the Department of Health to fill the vacant division chief staff position within the Environmental Management Division by 10/1/2021 and consider environmental justice issues when making certain assessments and determinations. Requires the Clean Water Branch to perform water quality testing during brown water advisories, inform the public of health risks associated with water runoff during brown water advisories, and establish an Environmental Management Division Oversight Advisory Board. Requires the Legislative Reference Bureau to conduct a comprehensive review of the Environmental Management Division.
