A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 286-41, Hawaii Revised Statutes, is
- 2 amended by amending subsection (e) to read as follows:
- 3 "(e) Notwithstanding any other law to the contrary, the
- 4 director of finance of the county in which the application for
- 5 registration is sought shall [not] require proof of insurance as
- 6 a condition to satisfy the requirements of this part. This
- 7 subsection shall apply [only] to the initial [registration] and
- 8 every subsequent registration of any motor vehicle."
- 9 SECTION 2. Section 286-45, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "§286-45 Records of county finance director. The director
- 12 of finance shall file each application received and register the
- 13 vehicle therein described in a record or book to be kept by the
- 14 director of finance under the following headings:
- 15 (1) Vehicle registration number;
- 16 (2) Name of owner; [and]
- 17 (3) Vehicle identification number [-]; and



1	(4) Motor vehicle insurance policy number, insurer, and		
2	policy period for the vehicle.		
3	The director of finance may microfilm vehicle registration		
4	and ownership records which are a year old and may discard the		
5	original records. The director of finance may discard vehicle		
6	registration and ownership records which are older than six		
7	years."		
8	SECTION 3. Section 286-52, Hawaii Revised Statutes, is		
9	amended by amending subsections (i) and (j) to read as follows:		
10	"(i) Every dealer, upon transferring a motor vehicle,		
11	whether by sale, lease, or otherwise, shall immediately give		
12	notice of the transfer to the director of finance upon the		
13	official form provided by the director of finance. Every such		
14	notice shall contain the date of the transfer, the names and		
15	addresses of the transferor and transferee, and such description		
16	of the vehicle as may be called for in the official form. Every		
17	transferee shall immediately give notice to the director of		
18	finance upon the official form provided by the director of		
19	finance the name of the motor vehicle insurer and the motor		
20	vehicle insurance policy number that will provide the transferee		
21	with coverage for the motor vehicle.		

Every person, other than a dealer, upon transferring a 1 (i) motor vehicle, whether by sale, lease, or otherwise, shall 2 3 within ten days give notice of the transfer to the director of finance upon the official form provided by the director of finance. Every notice shall contain the date of transfer, the 5 names and addresses of the transferor and transferee, and such 6 description of the vehicle as may be called for in the official 7 8 form. Every transferee shall immediately give notice to the 9 director of finance upon the official form provided by the 10 director of finance the name of the motor vehicle insurer and the motor vehicle insurance policy number that will provide the 11 12 transferee with coverage for the motor vehicle. Any person who 13 violates this subsection shall be fined not more than \$100." SECTION 4. Section 286-61, Hawaii Revised Statutes, is 14 15 amended to read as follows: "§286-61 Penalty. Any person who violates sections 16 286-41, 286-42, 286-44.5 to 286-56.5, and 286-58 to 286-60 shall 17 18 be fined not less than \$5 nor more than \$1,000; provided that any corporate owner of a motor vehicle who fails to register a 19 motor vehicle as required by section 286-41(a) following a 20 21 transfer of the vehicle between counties shall be fined \$1,000

- 1 for each violation[+]; provided further that any person who
- 2 fails to maintain motor vehicle insurance on the motor vehicle,
- 3 as required under article 10C of chapter 431, throughout the
- 4 period of registration shall be fined not less than \$500 nor
- 5 more than \$2,000 for each day that the motor vehicle is not
- 6 covered by that motor vehicle insurance. Any person who
- violates section 286-43, 286-44, or 286-57 shall be fined not 7
- 8 less than \$5 and not more than \$1,000 or imprisoned not more
- 9 than one year, or both."
- 10 SECTION 5. Section 431:10C-107, Hawaii Revised Statutes,
- is amended by amending subsection (a) to read as follows: 11
- 12 "(a) Every insurer shall issue to its insureds a paper or
- 13 electronic motor vehicle insurance identification card for each
- 14 motor vehicle for which the basic motor vehicle insurance
- 15 coverage is written. The electronic motor vehicle insurance
- 16 identification card may be accessed directly through the
- 17 licensed insurer's website, application, or database. The
- 18 identification card shall contain the following:
- 19. (1) Name of make and factory or serial number of the motor
- 20 vehicle; provided that insurers of five or more motor
- 21 vehicles which are under common registered ownership



1		and used in the regular course of business shall not	
2		be required to indicate the name of make and the	
3		factory or serial number of each motor vehicle;	
4	(2)	Policy number;	
5	(3)	Names of the insured and the insurer; [and]	
6	(4)	Effective dates of coverage including the expiration	
7		date[-]; and	
8	(5)	The motor vehicle registration period of the motor	
9		vehicle and the name of the county director of finance	
10		who issued the registration certificate and license	
11		plates for the vehicle."	
12	SECT	ION 6. Section 431:10C-112, Hawaii Revised Statutes,	
13	is amende	d by amending subsection (a) to read as follows:	
14	"(a)	In the case of cancellation or nonrenewal of a motor	
15	vehicle insurance policy by the insurer, the insurer shall mail		
16	[a written notice] written notices of prospective cancellation		
17	or nonrenewal to the insured and the county director of finance		
18	who issued the registration certificate and license plates for		
19	the vehicle not fewer than thirty days prior to the effective		
20	date of t	he cancellation or nonrenewal. The insurer shall	
21	continue	all motor vehicle insurance and optional additional	

2	provided	that in the case of cancellation for the nonpayment of	
3	premiums	the insurer shall:	
4	(1)	Mail [a written notice] written notices of prospective	
5		cancellation to the insured and the county director of	
6		finance that issued the registration certificate and	
7		license plates for the vehicle not fewer than twenty	
8		days prior to the effective date of the cancellation;	
9		and	
10	(2)	Continue all motor vehicle insurance and optional	
11		additional coverages in force for twenty days	
12		following the mailing.	
13	Canc	ellation or nonrenewal shall not be deemed valid unless	
14	the maili	ng required by this section is supported by a	
15	certifica	te of mailing properly validated by the United States	
16	Postal Service."		
17	SECT	TION 7. The legislature finds and declares that the

Car Insurance; Motor Vehicles; Registration

Description:

Requires motor vehicle insurers to notify the county director of finance of cancellations and nonrenewals of motor vehicle insurance policies on registered vehicles. Requires transferees to notify the county director of finance of motor vehicle insurance policy coverage for the transferred vehicles. Increases registration fines for a failure to maintain insurance on the vehicle during the period of registration.
