A BILL FOR AN ACT

RELATING TO EXPUNGEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 706, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§706- Expungement; records relating to homelessness.
- 5 (a) Notwithstanding any law to the contrary, upon written
- 6 application, a person may apply to the court for an order to
- 7 expunge from all official records all recordation relating to
- 8 the person's citation, arrest, indictment, or information,
- 9 trial, finding of guilt, dismissal and discharge, or other
- 10 disposition for any and all offenses described under section
- 11 708-814.7, 711-1105, and any statute, ordinance, or rule not
- 12 involving bodily harm or the threat of bodily harm, where the
- 13 person's conduct or alleged conduct underlying each offense was
- 14 substantially related to the person's homeless status.
- 15 (b) If the court determines that the person:
- 16 (1) Has satisfied all requirements of any judgments
- 17 relating to the offense or offenses described in the

3	(2)	Has expressed a willingness to seek financial or
4	1	mental health counseling, if financial or mental

7	the court	shall enter the order and shall waive any outstanding
8	fines and	fees associated with the described offense or
9	offenses.	The order shall include all recordation retained by

13	person, in	the contemplation of the law, to the status the
14	person occ	upied before the citation, arrest, indictment or
15	information	n, trial, conviction, dismissal and discharge, or

17	(d) 1	No person to whom the order has been entered shall be
18	held there	after under any provision of any law to be guilty of
19	perjury or	otherwise giving a false statement by reason of the
20	person's f	ailures to recite or acknowledge the citation, arrest,
21	indictment	or information, trial, conviction, dismissal and

1	discharge, or other disposition in response to any inquiry made
2	of the person for any purpose.
3	(e) A document substantially in the following form may be
4	used to apply for a court order to expunge from all official
5	records all recordation as described in this section; provided
6	that the court may designate the time and location of filing and
7	may require additional information necessary to establish the
8	identity of the applicant whose records are being expunged and
9	to make a determination as to whether the conduct or alleged
10	conduct underlying any offense was substantially related to the
11	person's homeless status at the time of the offense.
