A BILL FOR AN ACT

RELATING TO REGISTRATION OF VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that some individuals and
- 2 entities intentionally abandon vehicles on roads and highways
- 3 throughout the State, and that it is difficult for the counties
- 4 to recoup the costs of towing and disposal. The legislature
- 5 further finds that if the counties were able to require that the
- 6 costs of towing and disposal be paid as a condition precedent to
- 7 registration of vehicles, the counties would have an easier time
- 8 recouping their costs.
- 9 SECTION 2. Section 286-51, Hawaii Revised Statutes, is
- 10 amended by amending subsection (a) to read as follows:
- "(a) The certificate of registration for each motor
- 12 vehicle in the counties of the State shall be renewed on a
- 13 staggered basis as established by each county. The director of
- 14 finance of each county may adopt rules to carry out the purposes
- 15 stated in this section and shall expend the necessary funds from
- 16 the director's operating funds as may be necessary for these
- 17 purposes; provided that the director of finance, if the director

11	registered owner shall not be required to pay the outstanding	
12	charges if:	
13	(1)	The abandoned or derelict vehicle has been stolen or
14		taken from the registered owner without permission or
15		authorization; and
16	(2)	The registered owner has filed a police report
17		documenting the theft or unauthorized use of the
18		abandoned or derelict vehicle prior to the issuance of
19		any charges, fines, or amounts due for the towing,
20		removal, or disposition of the abandoned or derelict
21		vehicle.

1 The certificates of registration issued hereunder shall 2 show, in addition to all information required under section 3 286-47, the serial number of the tag or emblem and shall be 4 valid during the registration year only for which they are 5 issued. The certificates of ownership need not be renewed 6 annually but shall remain valid as to any interest shown therein 7 until canceled by the director of finance as provided by law or 8 replaced by new certificates of ownership as hereinafter 9 provided." 10 SECTION 3. Section 286-52, Hawaii Revised Statutes, is 11 amended by amending subsection (c) to read as follows: 12 "(c) Subsection (b), requiring a transferee to forward the 13 certificate of ownership after endorsement to the director of 14 finance, shall not apply to the transferee of a vehicle who was 15 not intending to and does not drive the vehicle or permit the 16 vehicle to be driven upon the public highways, but every such 17 transferee, upon transferring the transferee's interest or title 18 to another, shall give notice of the transfer to the director of 19 finance and endorse the certificate of ownership to the new 20 legal owner and the certificate of registration to the new 21 owner; provided that if the director of finance has ascertained

11	be requir	ed to pay the outstanding charges if:	
12	(1)	The abandoned or derelict vehicle has been stolen or	
13		taken from the registered owner without permission or	
14		authorization; and	
15	(2)	The registered owner has filed a police report	
16		documenting the theft or unauthorized use of the	
17		abandoned or derelict vehicle prior to the issuance of	
18		any charges, fines, or amounts due for the towing,	
19		removal, or disposition of the abandoned or derelict	
20		vehicle."	

- 1 SECTION 4. Statutory material to be repealed is bracketed
- 2 and stricken. New statutory material is underscored.
- 3 SECTION 5. This Act shall take effect on July 1, 2021.
