A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is amended by adding a new section in part V to be appropriately 2 designated and to read as follows: 3 "§302A- Financial and management audits. The auditor 4 shall conduct an operational audit of the academic plans and the 5 financial plans of the department, assessing the efficiency and 6 7 effectiveness of the process from budget and planning, and implementation to student outcomes annually. The auditor shall 8 9 submit a report of the auditor's findings, including any 10 proposed legislation, to the legislature no later than twenty days prior to the convening of the regular session following the 11 12 audit." SECTION 2. (a) The department of education shall contract 13 with a third-party consultant that specializes in school finance 14 to perform a study of the adequacy of education funding in

Hawaii. The third-party consultant shall have previous 16

experience conducting studies of education systems in multiple
 states.

3 (b) The study shall:

Employ the evidence-based method to evaluate the 4 (1) adequacy of school funding, but may include the 5 professional judgement method in its analysis; 6 Identify variables most closely associated with a (2) 7 high-quality education and estimate the amount of 8 9 additional funding needed to provide all public school students in Hawaii with an equal educational 10

11 opportunity;

12 (3) Compare Hawaii teacher salaries with teacher salaries
13 in school districts of similar size and cost of living
14 to determine compensation characteristics that impact
15 the department of education's ability to recruit and
16 retain effective teachers; and

17 (4) Assess the equity of funding between schools
18 throughout the Hawaii public school system.
19 (c) The department of education shall submit to the

20 legislature a copy of the study, along with a report of its

legislation, no later than twenty days prior to the convening of
 the regular session of 2023.

3 SECTION 3. There is appropriated out of the general
4 revenues of the State of Hawaii the sum of \$ or so
5 much thereof as may be necessary for fiscal year 2021-2022 and
6 the same sum or so much thereof as may be necessary for fiscal
7 year 2022-2023 for the office of the auditor to conduct the
8 operational audits required by section 1 of this Act.

9 The sums appropriated shall be expended by the office of
10 the auditor for the purposes of this Act.

SECTION 4. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2021-2022 for the department of education to contract with a third-party consultant that specializes in school finance to perform a study of the adequacy of education funding in Hawaii as required by section 2 of this Act.

18 The sum appropriated shall be expended by the department of 19 education for the purposes of this Act.
