A BILL FOR AN ACT

RELATING TO THE BOARD OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 302A-1106.5, Hawaii Revised Statutes,
- 2 is amended to read as follows:
- "§302A-1106.5 Board of education; community [meetings.] 3
- [The board shall hold not less than one community 4
- meeting annually in each county in] In addition to their regular 5
- meetings, the board shall hold no less than six community forums 6
- 7 annually to discuss and receive input from the community on
- public education and public library issues [-]; provided that the 8
- 9 board shall hold at least one community forum in each county.
- 10 The board chairperson shall designate less than a quorum of
- 11 board members to attend [the] each community [meetings.] forum.
- 12 These community [meetings] forums shall not be held for the
- 13 purpose of formulating educational policy. The community
- [meetings] forums shall be [exempt from sections 92 2.5, 92-7, 14
- 92-9, and 92-41; provided that the board shall give written 15
- public notice of each community meeting. The meeting notice 16
- 17 shall indicate the date, time, and place of the meeting, and



- 1 shall be filed in the office of the lieutenant governor and in
- 2 the board's office for public inspection six calendar days
- 3 before the meeting. The notice shall also be posted at the site
- 4 of the meeting.] a permitted interaction under section 92-2.5;
- 5 provided that no commitment relating to a vote on a matter is
- 6 made or sought. At the next duly noticed meeting of the board,
- 7 the board members shall report their attendance and the matters
- 8 presented and discussed at the community forum."
- 9 SECTION 2. At any public meeting properly noticed pursuant
- 10 to chapter 92, Hawaii Revised Statutes, the board of education
- 11 shall include an open forum at the end of its meeting agenda to
- 12 afford all interested persons an opportunity to present oral
- 13 testimony on any matter not on the agenda; provided that the
- 14 testimony is related to matters over which the board of
- 15 education has supervision, control, jurisdiction, or advisory
- 16 power.
- 17 SECTION 3. The board of education shall report to the
- 18 legislature no later than twenty days prior to the convening of
- 19 the regular session of 2022 on its efforts to amend its polices
- 20 to include an open forum at the end of its meeting agenda to

- 1 afford all interested persons an opportunity to present oral
- 2 testimony on any matter not on the agenda.
- 3 SECTION 4. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 5. This Act shall take effect on July 1, 2021.
